Dear Mrs Cram,

I am writing in connection with the letter I received from Ms H. Lawson, former President of your Association, dated 8th February, 1984, seeking the special application of Community Employment Programme funding to alleviate staffing problems of country libraries in New South Wales.

I have given careful consideration to your Association's submission but I regret that it is not possible to provide assistance in the way that has been sought.

There are two barriers to the Government acting on the basis of your submission. Firstly, in accordance with the guidelines laid down by the Commonwealth Government, all positions under job creation schemes are filled from vacancies from Commonwealth Employment Service registers. Although I understand the Ministry of Employment has received many applications for the funding of libraries, the Commonwealth Employment Service is unable to provide qualified librarians and library technicians for those projects.

In this regard, any assistance your Association might be able to provide in encouraging unemployed library staff and graduating students to register with the Commonwealth Employment Service would be welcomed and may enable the Ministry of Employment to fill many of these positions referred to above.

Secondly, your submission has requested that staffing be on a permanent basis on the grounds that the short-term appointments were not beneficial. Again, in line with Commonwealth guidelines, most of the job creation programmes provide for shorter term employment than that sought by the Association.

The Federal Minister for Employment and Industrial Relations recently announced changes to the guidelines whereby the minimum level of financial contribution required of local Government and community organisations has been reduced to 20 per cent of project costs. Under these revised guidelines assistance may be more easily available under the programme for country librarians than was previously the case.

While I regret that I have not been able to be of more assistance to you in this matter, your Association can be assured that the Government is sympathetic to the needs of public libraries and to the difficulties they face in maintaining services and the Government will continue to monitor the funding levels afforded public libraries in New South Wales.

MASTER OF ARTS

(Recognized by the L.A.A. as conferring eligibility for Associateship.) Applicants must hold at least an Honours Degree (preferably at H1 or H11A level) in Science, Arts, Economics, Law, Engineering or other discipline considered relevant. The course consists of course-work and a minor thesis, and relates the student's academic discipline to librarianship. Normally the course is 2 years full-time, but part-time appli-

cants will be considered.

Either by course-work and a minor thesis (60%, 70%, 80%) or major thesis. Applicants must be graduate professional librarians, with a wish to engage in research towards a thesis.

DIPLOMA IN LIBRARIANSHIP

(Graduate Post-Professional Award) Course-work spread over one year full-time or 2 years part-time. Applicants must be graduate professional librarians. All the courses offered for the M. Lib. are available to Diploma students.

Among the School's specializations are: the provision and management of computer-based services; the economics of library and information provision; library services for ethnic minorities; the transmission of texts in the past and future; library and book trade history; computer applications in bibliographic control including the use of ABN.
