

## ONLINE PATENT DATABASES

1985 seems to be the year to promote online patent databases. INPADOC database and Derwent's WPI (World Patent Index) database are to be promoted in Australia by visitors from their head offices in England.

The INPADOC patent database is very comprehensive with input provided by all the Patent Offices throughout the world and each country's patent is loaded as a separate record. The file is searchable by patent classification number (IPC), inventor, assignee, country and all the patent numbers.

Pergamon Infoline is also of interest because of its Video Patsearch system for the US patents. The words are mounted on a normal online system — the pictures (diagrams, chemical symbols etc) are on a video disk searched at the same time.

The DERWENT patent files have world wide coverage but it is quite a different database from INPADOC. Derwent is a commercial concern involved in patent information. It takes the product from the various Patent Offices throughout the world and rewrites title and abstract in descriptive English instead of legal patentese. It excludes some countries and loads all the patent families from each country on the same record. Keyword indexing is provided as well as the patent classification and there are indepth indexing codes for chemicals and plastics.

Barry Mellor from Derwent in London will be on a promotional/training visit late July, early August and will go to Perth, Melbourne, Canberra, Sydney, Brisbane and Adelaide. Canberra Online Users Group will be Thursday 1 August. Contact Jean Geue (062) 33 2304.

Document delivery for patents is really quite easy. Most are held in the Patent Office in Canberra. Make sure you quote country and number — with patents they are more important than author/title.

I acknowledge with much pleasure receipt of your letter of 9 April conveying the resolution of the General Council of the Library Association of Australia in relation to the recent fire in the National Library.

The Library greatly appreciates the concern of the Association and its offer to help and I will have great pleasure in conveying the resolution of General Council to the Council of the National Library of Australia as yet a further heartening indication of the regard in which the Library is held in the library community in Australia.

At the moment, however, I cannot see any way of taking advantage of the Association's kind offer to assist. The process of rehabilitation proceeds, I think, as rapidly as could be expected. A bedevilling complication is the continued interruptions flowing from the process of asbestos removal, which was itself further complicated by the fire.

We have received nothing short of the greatest possible co-operation from the range of bodies and authorities involved in our struggle back to normalcy and, while it is clear that this process will not be complete in my time, it will be well on the way.
