

Wider distribution needed

I have recently been shown a copy of a Board of Education paper entitled *Professional Membership* — a review of Association policy, the covering letter for which dated March 1, from the Assistant Executive Director, states that 'the Board is seeking the views of Divisions, members and other interested parties on these proposals. Comments should be forwarded to the Assistant Executive Director by Wednesday May 15.

The paper came into may hands almost accidentally this morning (Monday May 6), and it was the first intimation I had had that the Board was actively considering the questions of a 'currency component' for new applicants for Associateship, and the widening of the eligibility criteria for it, so as to allow the admission of qualifications from fields other than librarianship.

All of which is proper and reasonable. What is not so, is the fact that our normal channels of communication, i.e. circulation of the paper to Divisions, do not ensure that the paper will be seen, much less discussed, by all interested members. If the Association wishes to have such papers considered by the membership at large, some more effective system of distribution needs to be found. I am loth to suggest publication in the ALJ, since it lacks a necessary currency, being a quarterly journal; InCite would be more appropriate, either within the normal columns, or as a series of occasional papers. If the Board of Education, or any other of the Association's many subsets, wants informed contributions from the membership - and I am sure this is what is sought — then the membership must be given the same opportunity to peruse and reflect as is extended to the members of the Association's Divisional Councils.
