
THE SOURCE

Now in its fourth edition, *Reference sources* for small and medium-sized libraries is worth another squiz. Most un-camel-like but compiled, I am assured, by an ad-hoc committee of the American Library Association, this work, like its predecessors, is a detailed annotated yet select guide to the most useful ref. books. Its antecedents appeared in 1968, 1973 and 1979 under the title *Reference books for* small and medium-sized libraries.

It is geared not just to American public libraries, but also to college and large secondary school libraries. For the first time with this edition deliberate efforts have been made to cover (and to tag) reference materials for children and young adults. 1788 items are listed and described under 22 headings and an array of subheadings. The emphasis is clearly upon works published or distributed in the United States, and foreign-language materials have been generally excluded.

Australian librarians will find this work useful in a number of ways: as a checklist when evaluating their reference collections, as a selection tool and as a guide to basic reference sources. In all these applications the present work will rub shoulders in the American and British markets at least with a goodly number of other guides. It roundly deserves a place on all our shelves, and is excellent value at US\$20.00.

Impeccable references

Any publication which can bring together Walford on encyclopaedias, Whatmore on newspapers as sources of information, Harold Nichols on maps, Ollé on government publications and K.G.B. Bakewell on indexing, plus other contributors of similar stature, is obviously getting off to a good start.

Nineteen distinguished librarians congregate in the pages of the second edition of Printed reference material, edited by Gavin L. Higgens and published by the Library Association last year. This work is in the 'Handbooks on library practice' series, and in its twentytwo chapters introduces various facets of reference work under broad categories, such as reports and theses, dictionaries, statistics, local studies, bibliographies variously classified and so on. The approach adopted is generally introductory - although there is inevitable and acceptable variation between contributors - with descriptions of forms of material and some historical background, notes on how to evaluate reference works in various categories, and detailed descriptions of a number of key works.

For exhaustive treatment, the reader is referred to other standard guides to reference works, but Printed reference material does include a goodly number of references and descriptions of more specialised or peripheral works, illustrating the range of materials available. So whilst this is a good format for the student or beginning librarian, it is also an excellent guide for those seeking a refresher. And it is eminently readable. Those who have used the first edition, which was published in 1980, will know something of its worth, which has certainly been augmented by new chapters on printed visual sources (where to start looking for a picture of Buckingham Palace before the 1913 alterations, and other curly ones), indexes and videotex (to supplement Bernard Houghton's very useful chapter on online information retrieval services). The two chapters contributed by the editor himself, on what reference work and reference materials are all about, are sensible, informative, full and well-written.

As you may have deduced, I can warmly recommend *Printed reference material*, second edition, edited by Gavin L. Higgens, and published in 1984 by the Library Association. At £12.50 for the paper edition, it's excellent value for money. My review copy was supplied by James Bennett Pty Ltd. (ISBN 0 85365 776 9 (paper); ISBN 0 85365 995 8 (cased)).


In a nutshell

It focuses on short management courses, from accident prevention to supervision and quality control. There is some New Zealand coverage. Entries are compiled from paid insertions by organisations offering courses. It doesn't claim to be exhaustive. Prepublication price for the 1984 edition was \$65.00.
