### **Irade Union Information Kit**

The Trade Union Information & Resource Centre of the Victorian Trades Hall Council has produced a Trade Union Information Kit and a series of posters, to explain the role of grade unions in Australian society.

### STUDY GRANT FOR CARMEL MAGUIRE

Associate Professor Carmel Maguire, Head of the School of Librarianship at the University of New South Wales, has been awarded a grant of \$15,000 from the Australian Research Grants Scheme. The grant is for a study to begin in 1986 in which Professor Maguire will study sources of, and access to information about markets and technology in traditional manufacturing and in high technology enterprise.

#### South Australian Workers Compensation Reform Proposals

Proposals for change in the South Australian Worker's Compensation System which were contained in a working paper on reform of the system, which was released in August, are being modified by negotiation before legislation is introduced into Parliament.

The South Australian Government has said that it intends to introduce legislation in the form of a Workers Rehabilitation & Compensation Act in the current session of Parliament.

# Copyright regulations amended

The Attorney-General's Department advises that the Copyright Regulations have been amended. The prescribed retention period for records under Sections 49, 50, 51A, 53B and 53D of the Copyright Act and the period for making claims under Sections 53B and 53D have been extended from three to four years. The amendment was made on 26 July 1984.
