

I would like to make some comments on the future role of the Association of Local Government Librarians.

Whilst sitting in a Council meeting the other night, I noted from the Business Paper that the Local Government Community Services Association were having a two-day Conference in the near future. This Association comprises community workers, youth workers, arts officers, and other groups in this field. The thought struck me that Local Government librarians are a divided lot, being members of the Library Association, and Public Libraries Section, The Association of Local Government Librarians, or some library association section, such as cataloguers, or children's librarians, or not a member of anything.

In Local Government there are a number of associations, some unions, some not. The Town Clerks' Society (union), the Local Government Engineers' Association (union), Health Surveyors' Association (union), Town Planners' Association (not a union), Community Services Association (not a union).

These associations represent the majority of Local Government employees in these areas (whilst the Association of Local Government Librarians represent a minority) and can argue points for members with considerable clout, either with the Local Government Association, State Government, or the public generally.

Whilst not denigrating the Library Association or the Public Libraries Section or Children's Librarians' Section, it is doubtful whether these are the correct organisations to represent public librarians in this day and age.

By all means be a member of the LAA, but I feel that Local Government Librarians should be represented by the one association which should hold an annual Conference to which appropriate Ministers of the Crown, Local Government Association Officials, Aldermen and Clerks should be invited to attend, and that such a Conference should be a prestige event. (This view also has some interstate implications which I do not propose to touch upon at this point.) The dissipation of talent and leadership in the field of public librarianship, the lack of a unified voice on matters concerning public librarians are of real concern, particularly when attempts are made to downgrade the public librarian's position in Local Government.

POLITICIANS ONLINE

The Australian Political Register (APOL) which was released on Ausinet in February, is the first directory of local politicians availabe online in Australia.

Both the database producer (Australian Consolidated Press) and the vendor (ACI computer Services), believes it will meet a big need in Australian libraries.

APOL will provide details of:

- all Federal and State politicians (with short biographies of all Ministers)
- Upper and Lower Houses in the Federal and each State Parliament
- all State and Federal ministries, plus the shadow ministries for the main opposition party in each case
- the officials of any political party which has at least one member elected to an Australian parliament
- the heads of all diplomatic delegations to Australia
- Australian diplomats abroad

With time the Register will grow to include people who have held political office in Australia but who do not currently do so. For instance, when Bill Hartley was expelled from the Victorian ALP in February, he was not similarly booted out of APOL. Justamended. . . .

In the coming months APOL will be expanded to include government departments and ministerial staff. Further expansions in other areas are planned.

APOL should be particularly useful to anyone in the political field, in media, in marketing, libraries, researchers, academics and lobbyists, and companies and individuals who ever have need to contact government or politicians.

It is the second database produced by Australian Consolidated Press to be released on AUSINET. The full-text of Australian Business (AUSB) went up in September last year. The full-text of economic and political articles from *The Bulletin* will be ready for release later this year.

APOL is true electronic publishing. It exists only as an electronic database with no printed version. It is AUSINET's 44th database, joining a stable of economic, financial and business-oriented databases. 'APOL further enhances the usefulness of Australia's very own public access database service,' said Mark Wilson, of ACI Computer Services.
