The topic was retrospective conversion, and was presented by a panel of five speakers, representing most of the larger institutions presently engaged in retrospective conversion in Brisbane. They were Ann McLean, (Brisbane City Council Library), Bruce Edwards, (Griffith University), Carolyn Chalmers, (Queensland Institute of Technology), Anne Walton, (State Library of Queensland) and Mary-Rose McCarthy, (University of Queensland.)

Each speaker addressed the following five points:

- 1. Type of conversion (card to automated percentage of records already converted.
- 2. Outside agencies used and the pros and cons of using them.
- 3. Resources (staff, money, time, equipment) needed.
- 4. Priorities, time constraints, etc.
- 5. Pitfalls.

The discussion ran overtime, but many of the audience were reluctant to leave, which just goes to show how interested cataloguers are in their work! (and maybe in the cheese and wine?)

SCHOOL LIBRARIES SECTION NATIONAL

Books and beyond

The Steering Committee for the Commonwealth Schools Commission project 'Revision of *Books and Beyond: Information Needs of Schools*,' met for the first time in Canberra on 13 April 1987.

The project began in response to concern expressed by educators and teacher-librarians that the standards were out of date and needed revision. In addition the School Libraries National Section (then based in Victoria) made submissions to the Commission requesting funding for research on the current resources of Australian school libraries and on the introduction of information technology into post-primary schools via the school library. Late in 1986, the LAA was granted \$52,000 to support the project.

Members of the Steering Committee are: Dr R. Andrews, Full-time Commissioner Commonwealth Schools Commission (Chair); Mrs P. Mitchell, Part-time Commissioner Commonwealth Schools Commission; Ms S. Gapper, Department of Education, SA; Ms H. Coghlan, Department of Education, Queensland; Ms J. Hansen, Department of Education, NSW; Ms B. McConchie, ACT Schools Authority (Library Services); Mr A. O'Meara, Catholic Education Office, Victoria; Dr N. Johnson, Australian School Library Association; Mr P. Wilkie, National Council of Independent Schools; Mr P. Schaefer, Commonwealth Department of Education; Ms J. Kirk, Library Association of Australia; Mr G. Bull, Commonwealth Schools Commission.

At the first meeting the committee discussed the requirements and intention of the project and it was agreed that although there was still a need for a 'standards' document, it should be restyled so that it presents broad guidelines related to information resources and their use in schools. The guidelines could be used by planners, administrators, teachers and teacher-librarians.

In contrast to Books and Beyond 2nd ed., the proposed document will focus more on school curriculum and related issues such as information skills programs, the role of information in schools, information technology, equitable access to information, planning for an information rich school environment, and teachers' and students' information needs. The quantitative data of Books and Beyond will be revised and included as appendices.

The position of consultant for the project has been advertised in the national press. The appointment is for a nine-month term, during which the consultant is expected to visit at least all capital cities. The next meeting of the Committee is planned for 16 June.

Branch Council notes

The May meeting of the Victorian Branch Council was attended by two visitors, Peter Dawe, LAA President, and Alasdair Wardle, Convenor of the SOLV campaign. Peter spoke about the effects of the Corporate Plan, and the LAA program for the rest of the year.

Issues discussed included National Information Policy, the need for a paid local representative of the LAA in Victoria and Federal support for the SOLV Campaign. Alasdair spoke about the recommendations of the Geddes report on Victorian public libraries. It provides justification for a large reduction in the per capita grant to public libraries throughout the State and for the State Library to lose its role in supporting municipal libraries. SOLV has enlisted the support of the Municipal Association of Victoria to fight the State government on these issues. The

support of all Sections and Branches of the LAA is now sought in the run up to the State budget — ring your favourite politician, Write to newspapers etc.

Section membership

The change in the membership form has seen many members fail to nominate any Section in 1987. Section funding is based on a per capita grant calculated according to the previous year's membership of the group. In many cases Victorian Sections are showing a 50 — 75 percent drop in members and this will have a drastic effect on funding in 1988. LAA Head Office has agreed to accept late Section and Special Interest Group membership at \$5 each — support your Section or Group now or it may not exist in 1988!
