## Number Two Becomes Number One!

Ms Alison Crook has scored the number one job in NSW. In becoming the new State Librarian in NSW, she joins Jane La Scala in Victoria and is the second woman to become a State Librarian. The appointment was announced by the Minister for Planning and Environment and Minister for Heritage, Mr Bob Carr, on 10 September. She succeeds Russell Doust who officially retired on 21 September.

Ms Crook has experience in management and information technology. She holds an Honours degree in Philosophy, a Master of Business Administration, Graduate Diplomas in Education and Librarianship and has 15 years' experience in library policy and management.

Ms Crook has held varied positions within the LAA, including NSW Branch President in 1986. Since 1977 she has tutored in Philosophy of Education at Flinders University and has held the position of Deputy State Librarian at the State Library since June, 1982. In addition, Ms Crook worked in New Guinea as an Australian Volunteer Abroad and as a community liaison officer for Gunpowder Copper in Queensland. She is currently studying Japanese to assist in the development of a sister relationship with the Tokyo Metropolitan Central Library.

On the appointment of Ms Crook Mr Carr said 'I am extremely pleased to announce Ms Crook's appointment. She takes over the running of this important library at an exciting and sensitive time in its history.'

'Ms Crook will oversee the move of the Library's collections into the adjoining new 11



storey building in Macquarie Street in preparation for its official opening in April 1988.

'Her appointment reflects exciting changes for the Library and I am delighted that she will bring to it the benefits of her specialist knowledge and experience.'

And how does Ms Crook feel? She is obviously looking forward to the future and being at the helm of the new look State Library.

'For the past few years we have been laying the foundation for developments in new library services which will come to fruition with the opening of the new building next year' said Ms Crook. 'The opening of the new building with the refurbished old building linked to it, will see the State Library become one of the most exciting public places in Sydney.'

## Book indexing course

In the midst of the information explosion, a good and comprehensive index is essential for the efficient and effective use of any non-fiction book. The University of New South Wales School of Librarianship is offering an evening course in book indexing. It will be held on Tuesday evenings from 6pm to 9pm for six weeks from 3 November to 8 December.

The course is designed to cater for freelance indexers, indexers in publishing houses, editors responsible for indexing, and librarians responsible for compiling indexes and offers a grounding in all the major techniques of book indexing. Participants will be treated to lectures, group discussion, and (of course) take-home exercises.

For those with a publishing background there will be an introduction to information theory, and principles of subject access. And for those with a library background, an introduction to the world of publishing, and preparation of an index for publication. The fee for the six week course is \$135.
