Outlook is InCite's new occasional column of international notes. As many library staff do not have access to a wide range of overseas librarianship journals, the aim of this column is to keep members informed of professional developments overseas.

Free library service - the British Minister for the Arts, Richard Luce, has suggested that services provided by public libraries, other than basic services (which were not specified), should be charged for or put out to tender. The British Government has decided to introduce legislation which would allow Ministers to prescribe 'new or amended charging powers'. Implementation of this legislation would qualify and overrule parts of the Public Libraries and Museums Act 1964. The Library Association is attempting to counteract the threat to free public library services.

• Copyright – the British Copyright Act was passed in 1956, before many modern technological developments were in common use. A new Copyright Bill had its second reading on 17 November 1987.
