Environmentally friendly library book baas

On 7 May 1990 Brunswick City Council supported a proposal by the Brunswick Public Library staff to offer environmentally friendly library book bags for sale to the public. The library was authorised to purchase 200 'Just Jute' bags from Community Aid Abroad and to have the library's name screen-printed on to the bags.

These jute bags were produced in Bangladesh by a non-profit women's marketing trust which supports educational programs in literacy, health, and financial and family planning.

The bags are now available from the library at a price of \$3.30 as an environmentally friendly alternative to the plastic library book bags, which will be phased out of use.

Mike Hill said: 'This project was particularly pleasing to me because it was an initiative that came from the "shop floor". I am very happy to see that environmental initiatives are now coming from council staff, in addition to those proposed by councillors.

Obituary

The death occurred of the Hon. Mr Justice Hartigan, President of the Administrative Appeals Tribunal, on Tuesday, 24 April 1990. The President was aged 50 at the time of his death.

The President was appointed as a Judge of the Federal Court of Australia and President of the Administrative Appeals Tribunal (AAT) on 13 August 1987. Prior to these appointments he practiced as a barrister in Brisbane, having been admitted to the Bar in 1965 and taken silk in 1981.

The President had a very keen interest in libraries and was the Chairman of the Aquinas Library Advisory Committee. He was committed to opening the AAT's Principal Registry Library to the public. He believed that the public should have access to both the Library's comprehensive administrative law collection and to its professional reference services. He saw this as an essential step in making the Tribunal more accessible. On 5 March 1990 he officially opened Principal Registry Library to the public, at a small ceremony to commemorate this achievement.

The President will be remembered by all those who had contact with him as an approachable, friendly person with a lively interest in all events around him.
