

# Committee on Cataloguing

**John Thompson, ACOC Chair, poses three questions on which he would like the views of ALIA members**

**T**HE AUSTRALIAN Committee on Cataloguing (ACOC) met in November last year at the National Library. ACOC is currently seeking the views of Australian libraries and librarians on three matters:

- the library literature indicates a tentative move (within the USA) to re-open the issues of successive versus latest title entry for serials. Australian libraries by and large use successive title entry for serials, although there are still major collections catalogued under latest title and some libraries mix methods of entry to suit local circumstances. While it is presently committed to the concept of successive title entry, ACOC seeks views on this topic given the context of the NBD, networking, etc.
- ACOC has received expressions of concern about the need for large scale revisions of the Dewey Decimal Classification (DDC), as proposed by

the DDC Editorial Policy Committee. Such revisions may not be economical and may be short-sighted in an automated environment. We probably need new numbers for new subjects, not changed ones for established topics. What do you think?

- ACOC seeks assistance from librarians with subject and classification expertise in monitoring and proposing new DDC numbers in specific subject areas. Such people need to be able to commit themselves (and possibly their libraries) to irregular work in chosen areas of the classification (which might be a Dewey range of ten).

## RAY CHOATE RAISS BIENNIAL TRAVELLING SCHOLARSHIP

### CALL FOR APPLICATIONS

#### Aim

To provide a member of RAISS with the opportunity to travel to investigate and research a particular aspect of reference or information service provision, which will increase his/her professional experience and contribute to the knowledge of other RAISS members.

#### Objectives

The Ray Choate RAISS Biennial Travelling Scholarship will provide financial assistance for the undertaking of selected research projects designed to:

- explore the potential for further development of existing Australian reference or information services;  
*and/or*
- investigate the use of emerging technologies in the provision of reference or information services.  
*and/or*
- increase the knowledge and skills of practicing reference librarians.

#### Conditions

The Scholarship will be granted every two years, in the non-RAISS Conference year. In 1992 the Scholarship is valued at \$2,000. The successful candidate will bear any costs above this amount. The winner will be able to draw upon the funds one month after the Scholarship has been granted.

Applicants must be financial members of the Reference and Information Services Section of ALIA.

The project is to culminate in a substantial written report which must be presented to the National Committee of RAISS by June of the year following the granting of the Scholarship.

Scholarship recipients may be required to present a paper at the biennial RAISS Conference which immediately follows the culmination of the research project.

RAISS has first option to publish the results of any research that might arise from the Scholarship.

Under normal circumstances, the Scholarship will not be granted in conjunction with any other award.

## 1992 Master Tax Guide

For those with more complicated affairs, there are sections covering Partnerships, Trusts, Companies, Fringe Benefits Tax and Capital Gains Tax.

For businesses wishing to keep their tax down to a minimum within the law, the section on Taxation Planning is a must.
