

• the Executive Director as a non-voting executive member.

There shall be as a minimum 3 practitioners and 3 educators on the Board: practitioners shall be defined as persons working in the field of libraries or information services and educators as persons teaching library or information science.

Access points for information

The Upper Murray Regional Library experience

ublic libraries face a massive task in going on-line. Regional D public libraries face not only the problems involved with introducing automation in their libraries, but also a major hurdle in the fact that country telephone exchanges are inadequate for most electronic data transfer. The Upper Murray Regional Library is a case in point.

The Upper Murray Regional Library is a typical regional rural public library that covers a large geographic area, however, in this area there are four STD regions and only one branch with a local call rate from Albury-Wodonga. It is uneconomic to put all 15 branches on-line (it would cost over \$120,000 per annum to put all branchs on-line to process 210 000 loans) so the library developed a strategy where the larger libraries came online, closer smaller libraries dialup for the hours they are open, a hub is located at one library into which two others dial in, and five distant off-line libraries update overnight.

The biggest problem, after putting in place a system which allows this degree of flexibility, was the quality of the phone lines and the difficulty in getting prompt and action-oriented attention. Problems so far have been:

· At Wodonga two or the four wires

had corroded so an intermittent fault occurred (mux and modems dropping out). Telecom would not look at the line until all software and hardware had been double- and triple-checked

- At lerilderie an out of area line had to be put in especially for the library because of problems in the local exchange. Despite this provision the line speed of the modem had to be dropped to 2400 which of course costs more.
- The line speed at Mulwala also had to be dropped from 9600 to 2400.
- At Corryong whenever it rains the line drops out.
- At the hub at Culcairn Library there are constant problems with the lines dropping out. All the equipment has been tested, the modems have been reset to 2400, but the fault still persists. The lines from Holbrook to Culcairn and Henty to Culcairn also do not reliably operate at 9600 and there too the multiplexers have had to be reduced to a slower speed.

Librarians have the skill, interest and the structural ability to provide public access to electronic information, however, at this stage the superhighwav is only a gravel one with guite a number of potholes which can become impassable with heavy rain!
