The challenge of university library leadership...

owards the end of 1996 a rare opportunity came my way -- I got the chance to 'get her hands dirty' and work in private industry, outside of a library-specific role, and take up a one-month senior executive placement at NEC Australia.

The experience reinforced some basics about organisational leadership and management. Summarised and translated into the academic library context, the lessons I learned read something like this:

- · Never under-estimate political agendas.
- · Remain client focused.
- · Position the library into the wider organisational context.
- · Network actively and make sure the key decision makers understand and appreciate the role of the library.

- · Demonstrate and articulate how the library adds value to teaching, learning and research processes.
- · Keep abreast of developments within the parent institution and the wider community.
- · Market and promote your library's resources and service.
- · Communicate in a variety of wavs.
- Remember process is important, but focus on outcomes.
- Planning is important but keep it simple and understandable.

Devote some time and energy to answering these simple questions:

- · What is important to us and what actions and behaviours are unacceptable to us?
- · What business are we in and

- what would we like to be seen as? (mission)
- What do we hope to achieve in order to be successful?
- · How will we measure our progress towards achieving our objectives? (performance indicators)
- · Staff are the key to organisational success. Keep them informed about progress, consult them about change and work together.
- · The leader is judged by their achievements. Be professional and make sure your actions match your words.

If we thought we had experienced a time of change in libraries over the last decade, and if the experience of private industry is anything to go by, then as they say, 'we ain't seen nothing yet!'. Being a leader is more than challenging - it's a question of survival!
