Computers for librarians

State Library acquires historical manuscripts

The State Library of Victoria is delighted to announce that it has acquired a number of important historical documents written by John Pascoe Fawcner (1792-1869) about the settlement of Melbourne in its earliest years.

The Library's purchase will ensure that the documents will remain together as a group, the property of the people of Victoria, and available for study by historians and researchers.

The most significant documents acquired by the Library are:

- Fawcner's detailed sailing directions for navigating Port Phillip Bay;
- a detailed outline of the proposed settlement, incorporating 'land regulations' and the town planning principles to be applied. The 'land regulations' spell out the basis on which people would be able to acquire land, while the town planning proposals outline Fawcner's vision for sweeping boulevards and spacious squares in the future township;
- a detailed proposal for the constitution and form of government of the settlement — all males of twenty-one years of age and over being entitled to vote;
- Proposals for the provision of education and religion, including the compulsory education of children; and

- proposals for civil order in the settlement, particularly relating to the consumption of alcohol and the control of drunkenness in the settlement.

The papers demonstrate the degree of Fawcner's concern for the way in which the settlement was to develop. The extent to which Fawcner circulated these documents and made his opinions known in the infant settlement is not year clear. However, the documents are written on paper watermarked 1832, and it appears almost certain that they were drafted in the earliest stage of settlement. The documents therefore provide new possibilities for investigating the contribution made by Fawcner to the development of Melbourne.

This new material complements the Library's existing holdings, and will be placed with the John Pascoe Fawcner papers already held in the Manuscripts Collection.

The president of the Library Board of Victoria, Ian Renard, has thanked the Ivor Ronald Evans Foundation, through Equity Trustees, for its willingness to add a substantial donation to the funds made available by the Board and the Library Foundation in order to secure this fascinating collection of early Victoriana.

Selected items from the purchase will be on display in Queen's Hall at the State Library of Victoria from October to December. ■
