

Queensland pay equity report released

Just before *inCite* went to press, Commissioner Fisher of the Queensland Industrial Relations Commission released the report of that State's Pay Equity Inquiry, which she has conducted over the past six months. Its recommendations are currently being considered by the Queensland Government.

The report, among other things, recommends a new equal remuneration principle as the vehicle to address the pay inequity experienced by Queensland women. Commissioner Fisher identifies a gender pay gap of between 11 per cent and 17 per cent in Queensland workplaces.

ALIA made written submissions to the Inquiry, as a result of which a number of findings about librarians were made. The

Inquiry noted with concern the fact that, notwithstanding common classification structures for professional staff in the State's public sector, librarians' pay disadvantage had remained evident. In other words, the new structures had merely replicated the pay relativity that existed previously. Librarians were found to be concentrated heavily at the lower levels of professional classification structures, to their obvious detriment.

ALIA also raised the classification of local government librarians but this matter was not pursued by the Inquiry due to staffing resources and the fact that these employees are subject to federal awards.

ALIA rates well in national work/life survey

The prestigious Annual Work/Life Benchmarking Survey has recently been completed for the fourth time. The formal report on the survey has now been released and was the subject of national seminars during April.

Conflicts between work and family commitments are part of everyday challenges for many Australian employees. In the last few years more and more employers have come to understand

this as an issue that impacts directly on the profitability and efficiency of most industrial and service organisations. The survey canvasses initiatives and policies developed by Australian organisations to address the subject. Organisations are ranked according to the approach they have taken to balancing work and family issues for their staff.

ALIA's National Office took part in the survey this year and was ranked at the

31st percentile. Its procedures for assisting employees to balance work and family responsibilities were rated 84th from a field of 300 participating organisations. This means ALIA is among the top third of Australian organisations in terms of enlightened approaches to work/life initiatives.
