National Children's and Youth Services Awards

Bess Thomas Award and the Marjorie Cotton Award 2002

Entries are now being invited for the Bess Thomas and Marjorie Cotton Awards, presented by the National Children's Youth Services Group. Applications for both awards close on 31 January 2002, and both will be presented at the ALIA 2002 biennial conference in Sydney.

The Bess Thomas Award

The winner of the Bess Thomas Award will receive a \$250 grant towards a project initiating or supplementing public library services for young people. The aims of the award are to:

- encourage and support the development of innovative and significant public library services to young people;
- promote public and professional awareness of the importance of services to young people in public libraries; and
- honour the bequest made by Bess Thomas and commemorate her contribution to Australian children's libraries.

Applications may be made by individuals, public library services, regional services and co-operative networks.

Applications should include an outline of a proposal to develop services or supplement resources for young people in public libraries. The benefits of the project should be explained.

A written report from the winner will be submitted for publication in *Orana* and *inCite*.

The Marjorie Cotton Award

The Marjorie Cotton Award consists of a citation and certificate recognising an outstanding contribution to children's and youth library services.

tribution to children's and youth library services.

The aims of the award are to:

- promote the role and image of children's and youth services librarians;
- recognise individual achievement and co-operative networking in providing services for young people in public libraries; and
- encourage children's and youth services librarians to actively support the profession and the Association.

Any CYSS member who is employed as a children's or youth services librarian in a public library is eligible to apply for the award.

Nominations may be made by ALIA members, employers or colleagues. They require a proposer, a seconder and the nominee's consent.

Nominations will be judged according to their merits against the selection criteria. Applicants should be able to demonstrate an outstanding contribution to developing, implementing or promoting services to young people in libraries; active participation in co-operative networks, committees or groups furthering public library services to young people; and research, publication or presentation of a paper on the subject of children's/youth librarianship or literature.

Written reports will be submitted for publication in *Orana* and *inCite*.
