## Statement of professional concerns

To be an effective professional association ALIA must be recognised as a leader in the library and information services sector, setting directions in education and employment, lobbying for the industry with government in areas such as industrial relations and copyright, and collaborating with other compatible industry bodies both nationally and internationally. To successfully achieve this role ALIA must engage both the community and the membership in its activities. In particular gaining members' enthusiastic support for key programs and activities must be a goal for the Board of Directors. This requires effective communication strategies and presents an ongoing challenge for the Association.

# LISEKA developments

s reported in previous issues of inCite, the LISEKA framework aims to integrate education and training activities for LIS practitioners across their career. Its objective is to demonstrate the links between education for entry to LIS, work-place expectations, continuing professional development and ultimately the relationship of all these to ALIA membership categories, thus providing practitioners with a tool with which to map out and plan future career development.

To help ALIA members relate LISEKA to themselves and their own particular circumstances, the working group is developing a handbook which will help individuals to determine where they are situated within the framework and what their opportunities are for career advancement.

Developed as a user guide that will be mounted on ALIA's website, members will already be familiar with some of the content of the handbook. It builds on the strengths of current educational policy and standards but presents these in a different context together with new ideas. The guide outlines what LISEKA means for individual members and how it can help them identify areas in which they want to increase their knowledge and skills so they can move on to a new stage in their career or keep up to date at their current level.

At the same time the guide also suggests different types of learning activities, forming the LISEKA program, which individual members can undertake in further developing their careers. The range of activities includes formal tertiary courses, workplace programs, seminars and conferences and self-managed activities.

The program aims to provide members with a way to structure their learning in order to maximise opportunities to

keep up-to-date or advance their career.

Accompanying the description of the various activities is a step-by-step guide showing how to make the most of the learning experience and, most importantly, offering advice on what evidence of learning members need and how to record it for the ALIA CPD program. The guide also includes information about how members can participate in the program and gain direct benefits from the ideas encapsulated in the LISEKA framework.

The work completed in Stage 1 of the project underpins the handbook and has informed its development.
