In the United States school, public and academic libraries have absorbed more than \$50 million in funding cuts over the past year.
ALA has found that libraries in at least 41 states report funding cuts of as much as 50 per cent. The report also discusses general trends occurring in libraries as a result of funding cuts.

The study concludes that the Network is a significant public-sector information technology project which is steadily giving real benefits to the ordinary citizens to whom it is directed.

Telecommunications Network

The Senate Committee examined the capacity of the Australian telecommunications network in relation to the public switched telephone network, access to broadband services, investment patterns and requirements, regulatory issues and international telecommunications comparisons. The report concludes that Australia's telecommunications network was generally able to deliver adequate basic services to most Australians however significant weakness were found to exist.

Broadband adoption by agriculture and local government councils

Continued government support is needed to improve broadband access for councils, businesses and individuals in regional areas. A survey of 200 councils found that eighty-nine per cent of urban councils were on broadband, compared to fifty-nine per cent in rural areas. The report recommends that higher speed and lower cost broadband satellite services, or services that can compete with satellite, should be developed as a priority.

The report also considers ways that libraries could make themselves more attractive to young people and could work in partnership with schools, youth services and other agencies.
