A scholarly style should be adopted, in the format used in articles contained in current issues of *Australian Library Journal* (ALIA, Canberra).

Essays must be written in English. An abstract of 100–200 words should accompany each essay. Any illustrations or tables should be embedded in the text.

Essays should be submitted in electronic (preferably Word) format by e-mail to the editors.
