

Fifteen years at ALIA

Jennefer's 'Directline' this month is her last, marking a time for us to reflect on what she has done for the Association and its members.

Jennefer has served ALIA in the National Office since 1991. She began as membership services manager, was promoted to deputy executive director in 1993 and was appointed executive director in 1999. In announcing her appointment in 'Frontline', Craig Anderson, then the president, wrote that Jennefer brought to the role a unique combination of experience in managing a professional organisation and knowledge of the library and information services industry.

A major development during Jennefer's term as executive director was the building of relations between ALIA and government, sector bodies both locally and overseas, allied sector bodies, and the community through her collaborative and consultative approach to dealings within and outside the industry. She promoted ALIA to the international library community within IFLA and has established strong links with other library associations.

The process of moving — without winding up — the Association from the Royal Charter to incorporation under the Incorporations Law was devised and overseen by Jennefer. This has placed the Association in a position to move forward with the new structure as a public company limited by guarantee well in place.

She has always had a strong commitment to what most

members see as one of the most important roles of ALIA: the oversight of education and training standards for the profession and professional development for members. Her work as deputy executive director was focused on the raising of standards in these areas together with the implementation of additional member services to encourage membership growth. She was instrumental in gaining over \$1 million funding for the Association with the Aboriginal and Torres Strait Islander Employment Strategy.

Her membership of boards outside ALIA recognises her competence and strategic thinking. Jennefer holds the following positions:

- Chair and director, CREATE Australia Ltd. (formerly the Cultural Sector Industry Training Advisory Body);
- Director, Innovation and Business Skills Australia (IBSA);
- Australian Society of Association Executives (ACT)
