## **3rd ALIA Top End Symposium**

Technology, Visions or Nightmares: True Stories in the Territory

A large delegation of library professionals turned out for the 3rd ALIA Top End Symposium in Darwin, 7–8 October 2005. They came from all over the Northern Territory and also from interstate and overseas to attend what has become an important annual event in the local calendar.



Delegates were welcomed to the Charles Darwin University Palmerston Campus on the Friday afternoon. The symposium was officially

opened by Annette Burke, the Mayor of Palmerston, who spoke about keeping up with the latest trends in libraries and discussed the new Palmerston Public library (to be opened in March 2006).

Hayley Leaver of LexisNexis Australia welcomed our keynote speaker Di Thompson, librarian and webmaster at the Legal Services Commission in Adelaide. Di's topic was 'Having an IT nightmare? Rescue your vision from the dark side'. Di told the story of her experience at the Legal Services Commission, from the nightmare in 1988 to the realisation of her vision. She left us with a message — to be clear on our goals and to be passionate about our projects.

The symposium covered a wide range of issues associated with the chosen theme. Papers on the Friday included presentations on e-books, the digitisation of photographs and the implementation of X Box game consoles in public libraries in Darwin.

A highlight for most attendees would have to be the Symposium Dinner, held at Kantilla's Restaurant at Marrara. The guest speaker Valmai Hankel took us on an exciting journey with her humorous, and at times sad, tales of the outback in 'Sand and paper: a brief look at four Northern Territory explorers, with a glance at my own travels'.

On Saturday delegates were enthralled by papers on digital archiving, the marketing of new technology, assisted technology computers, the creation of the learning precinct in the Charles Darwin University Library, implementing electronic document management systems, technology challenges in distance education and the use of MultiScreen Channel at Darwin City Council Libraries.

The winner of the best paper (sponsored by Northern Territory Library) this year was Brian Lloyd, project officer at Northern Territory Library, who gave us an intellectual look at the old subject of print versus electronic with his interesting topic 'What's our business: book or wires?'.
