Licensing negotiations

If you aren't part of a larger library or a consortium, you may be feeling the need for some support when it comes to dealing with vendors. At <http://www.llrx.com/columns/deal3.htm> (published 15 January 2007) Kara Phillips has put together a column summarising the library literature that offers practical suggestions for licensing negotiations.

Six tips are used as headings – Do your homework, Seek input, Work out pricing, Manage your time, Set goals, and Follow through – and the references are summarised in a sentence or so, enabling you to quickly identify the ones that are useful to you. The reading covers subjects from selection policy to training users after purchase.
