VALE Jean Hagger

1917-2008

Jean Hagger, who died on 16th July 2008, was the foundation head of the Department of Librarianship at RMIT.

Jean began her career as a primary school teacher in 1937 but changed direction after being asked to set up the school library at East Coburg Primary School. She resigned from the Education Department in order to enrol at Melbourne University where she graduated with a BA whilst also working part-time in the library and completing her professional qualification.

In 1952 Jean worked in the library of the United States Information Service in Melbourne. The time spent there inspired Jean to seek experience in the United States. Returning to Melbourne she worked in the Baillieu Library and was a part-time lecturer for Registration classes run by the library training school attached to the State Library of Victoria. In 1960–61 she was awarded a Fulbright scholarship to study at the University of Illinois where she completed an MLS.

Jean was appointed to her position at RMIT in January 1963. She was a pioneer in Australia of undergraduate education for librarianship at tertiary level. She was also the first female head of department at RMIT and the only one in the Institute's first century. When, in 1964, she appeared before the Council to present a proposal for a two year undergraduate diploma course in librarianship, she was the first female to appear in a Council meeting.

Jean retired in 1977 and embarked upon a successful career as a freelance indexer. She was responsible for the indexes to five of the seven volumes of *Historical Records of Victoria*. Her achievements were recognised by the grant of life membership of the Australian Society of Indexers.

Jean made a significant contribution to professional education for librarianship and to indexing. She will be greatly missed.
