Public Library Ambassador program

The Public Library Ambassador program is an initiative of the ALIA Public Libraries Summit. Every public library in the country will identify library advocates in their community and choose one or more Public Library Ambassadors.

These people can be grass-root members of the community or celebrity advocates who will use their talent or fame to promote the value of public libraries in their lives, especially attracting media attention. Similar in concept to UNESCO's goodwill ambassadors, an important difference is that public library advocates will come from a broad cross-section of the Australian community.

Public Library Ambassadors will perform a role different from library advocates and supporters such as Friends of Libraries groups which work steadily to promote library services to a wider audience or their peers. Public Library Ambassadors are role models or high-profile champions with individual and compelling stories about the value of public libraries in their lives.

ALIA advocacy

ALIA continues our advocacy efforts through government submissions, including responding to the consultation paper on the Digital Economy Future Directions. The important issues covered in the paper include open access to public sector information, digital confidence including consumer privacy and online safety, development of digital skills,

regulatory framework including copyright, and measuring the digital economy and its impacts. Submissions are due by 11 February – look for ALIA's submission on our website soon after that date.

In collaboration with the Australian Libraries Copyright Committee (ALCC) and the Australian Digital Alliance (ADA), ALIA has put in a joint submission to the Productivity Commission on Copyright Restrictions on the Parallel Importation of Books. The joint submission strongly supports removal of the restrictions upon parallel importation of books. ALIA believes that greater competition will lead to an increase in the variety of books available and more competitively priced books, increasing their accessibility for Australians.
