### World Library and Information Congress: 76th IFLA General Conference and Assembly



14 – 19 August 2010, Brisbane, Australia

Libraries: Engaging, Embracing, Empowering

Brisbane is to host the World Library and Information Congress, the annual IFLA conference, in August 2010. This is a hugely exciting opportunity for those who work in libraries in Australia to engage with colleagues from around the world.

Responsibility for preparing for the conference falls to three parties: IFLA Headquarters (in the Hague), Congrex (a conferenceorganisingcompanybasedintheUK), and a National Organising Committee, which I chair. IFLA HQ and Congrex are both heavily involved in planning this year's conference in Milan, so much of the detail of our conference will not be known until later this year. As information becomes available it will be posted on these websites: http://www.alia.org.au/ifla2010/ and http://www.ifla.org/IV/ifla76/index.htm and on ALIA e-lists.

The conference will be held from 14 –19 August 2010 at the Brisbane Convention and Exhibition Centre. The Opening Ceremony will take place on Sunday 15 August and a series of conference programs and a substantial exhibition will be available until Thursday 19 August.

There will be a library tour day, overseen by Sharan Harvey of Brisbane City Libraries, on Friday 20 August. IFLA conferences vary considerably from those we enjoy in Australia. There is no central program or keynote addresses. Rather, IFLA sections and roundtables (see <a href="http://www.ifla.org/act-serv.htm">http://www.ifla.org/act-serv.htm</a> for more information) are allocated a period of time (typically a half-day) to present a program. Many of these run simultaneously, so there is always an opportunity to find something of interest. In addition to their program during the conference, many IFLA sections and other organisations organise satellite events either before or after the main event. We hope to see a number of these in Brisbane, elsewhere in Australia, in New Zealand, and in South-East Asia and the Pacific.

We have also seen an indication of delegate fees. All ALIA members are IFLA members, and are able to take advantage of the member rates. The early-bird fee is €415 for bookings made before mid-May 2010. A fee in Australian dollars will be set by IFLA later this year based upon prevailing exchange rates.

There will be lots of opportunities to get involved with the conference, as volunteers, hosts, speakers, and delegates. Please mark the dates in your diaries and share this message with colleagues.

#### The passion of NLS4



The ALIA New L i b r a r i a n s Symposium (NLS4) couldn't have come at a better time for me. I had graduated as a librarian five months prior to its

commencement, and already I was considering abandoning the career, even though I was still so excited by the profession and what opportunities might come my way. But with no luck finding a full-time job, I was at breaking point, ready to return to my days as a barista in a café.

It was the usual story of not enough experience, and no one giving me the chance to gain that experience. So there I was five months later, having received a rejection letter from my dream job, degenerated, with a hefty HECS bill, and ready to give up on being a librarian. I was broken. Searching for some hope, I hesitantly enrolled in the NLS4. I really needed to be inspired and that's exactly how came away with from NLS4.

They inspired me with the desire to learn more, make changes, think big and, ultimately, not to give up when barriers stacked themselves up around me. I was now no longer ready to weed myself from the library world.

It was great to hear so many librarians talk about their role in the profession and with such enthusiasm. Naturally, that same passion was awakened in the future leaders of libraries who now wanted to do more then sit on the sidelines. Without a doubt, the highlight for me was the intense passion and pride I took away about being a librarian, which, I've come to realise, is a secretly cool profession. Shhhh... don't spill the secret yet! We don't want the profession overcrowded (I'm still hunting for my dream job).

For all those new librarians out there who didn't get to attend NLS4 and are considering abandoning the profession, I urge you to be proud of what you are – a new-age librarian! Before you shelve yourself away in the back row aisles of the dusty stacks – remember you are the future! Proudly show-off your new, unread, untarnished pages of knowledge and enthusiasm. Don't give up – after all, there is nothing more enticing then a brand new book, and one day you'll meet the manager who, like most patrons, bypasses all the old well read books for that brand new one that offers so much.

Second notice of Annual General Meeting and call for motions

The 21st Annual General Meeting of the Australian Library and Information Association will be held on Tuesday 19 May 2009 at ALIA House

#### Rules of Meeting

- Motions for discussion at the AGM are to be forwarded in writing to the ALIA Executive Director, ALIA, PO Box 6335, Kingston ACT 2604 by
  Friday 6 March 2009. Motions should be signed by the movers either individually or on behalf of a division/group of the Association.
  All such motions received will be published in the AGM agenda notice in the March & April issue of inCite and on ALIAnet.
- 2. All motions to be put to the AGM must appear in this published agenda.
- 3. The only items that may be raised under general business are those of an informal nature, or those that are within the scope of the business already laid down. Motions of a substantial nature relating to items not covered in the notice of the meeting will not be allowed.
- 4. If any item of urgency arises which is not within the business of the meeting, the Chairperson has the power to accept it without notice or rule that notice must be given.
- 5. All motions additional to those on the printed agenda and in accordance with rule 4, and amendments, shall be in writing, signed by the movers (forms will be provided) and delivered to the Chair.
- 6. When addressing the Chair, the person desiring recognition will properly identify themselves, giving his or her name and affiliations. Only ALIA members may speak.
- Debate shall be limited to three minutes for each speaker; no speaker may have the floor twice on the same question until all who wish to speak
  have spoken.
- 8. Proxies. To be valid, proxies must be in the form set out in the Constitution item 8.2 and be in the hands of the ALIA Executive Director, ALIA, PO Box 6335, Kingston ACT 2604, email address: enquiry@alia.org.au, by 6:00pm AEST on 18 May 2009. Proxy forms must not specify how the holder of the proxy is to vote on specific areas. A proxy must also be a member. A form is available from ALIA National Office or on ALIAnet at http://www.alia.org.au/governance/
- 9. By general consent, if there be no objection, or by a two-thirds vote, any rule governing the debate may be suspended.
- 10. The Chair's rulings on procedural matters may not be debated. The reference for rules and their interpretation by the Parliamentarian will be Joske's *The law and procedure at meetings in Australia*, 10th ed, 2007. A Parliamentarian will be appointed to advise the Chair on procedures and to assist in determining the results of a poll of members present if necessary.
