EXPORT CONTROL (MISCELLANEOUS AMENDMENTS) BILL 1982

EXPLANATORY MEMORANDUM

(Circulated by authority of the Minister for Primary Industry, the Hon. Peter Nixon, M.P.)

OUTLINE

Export Control (Miscellaneous Amendments) Bill 1982

This Bill is associated with the Export Control Bill 1982. It incorporates amendments to legislation which are consequential on the Export Control Bill 1982.

A number of Acts contain a provision which governs the affect of those Acts on the Customs Act 1901, the Commerce (Trade Descriptions) Act 1905 and regulations under them. The Bill extends this provision to the new Export Control Act and regulations made under it.

Provision is made for the repeal of the Customs (Unlawful Exportation of Food) Amendment Act 1981, through appropriate amendments to the Customs Act 1901, and the Meat Export (Penalties) Act 1981. The provisions being repealed were introduced as urgent measures following the meat substitution activities last year.

The Commerce (Trade Descriptions) Act 1905 is amended by ommitting reference to the Minister for Primary Industry, the Secretary and officers of the Department of Primary Industry. The increased penalty provisions inserted by the Commerce (Trade Descriptions) Amendment Act 1981 (meat substitution) are repealed.

The Bill also provides for appropriate amendments to be made to legislation relating to the recovery of costs associated with the provision of the export inspection service.
