No. 20 of 1968

An Act to appropriate a sum out of the Consolidated Revenue Fund, additional to the sum appropriated by the Appropriation Act (No. 1) 1967-68, for the service of the year ending on the thirtieth day of June, One thousand nine hundred and sixty-eight.

[Assented to 22 May 1968]

B^E it enacted by the Queen's Most Excellent Majesty, the Senate, and the House of Representatives of the Commonwealth of Australia, as follows:-

- 1. This Act may be cited as the Appropriation Act (No. 3) 1967-68. Short title.
- 2. This Act shall come into operation on the day on which it receives Commencement. the Royal Assent.
- 3. The Treasurer may issue out of the Consolidated Revenue Fund Issue and and apply for the services specified in the Schedule to this Act in respect application of \$155,135,000. of the year ending on the thirtieth day of June, One thousand nine hundred and sixty-eight, the sum of One hundred and fifty-five million one hundred and thirty-five thousand dollars.

Appropriation.

4. The sum authorized by this Act to be issued out of the Consolidated Revenue Fund is appropriated, and shall be deemed to have been appropriated as from the first day of July, One thousand nine hundred and sixty-seven, for the services expressed in the Schedule to this Act in respect of the financial year that commenced on that date.
