An Act to grant and apply out of the Consolidated Revenue Fund the sum of Five hundred and eighty-seven thousand two hundred and nineteen pounds to the service of the year ending the thirtieth day of June One thousand nine hundred and three.

[Assented to 23rd June, 1902.]

**B**E it enacted by the King's Most Excellent Majesty, the Senate, and the House of Representatives of the Commonwealth of Australia for the purpose of appropriating the grant originated in the House of Representatives as follows :—

Preamble.

1. There shall and may be issued and applied for or towards making good the supply hereby granted to His Majesty for the service of the year ending the thirtieth day of June One thousand nine hundred and three the sum of Five hundred and eighty-seven thousand two hundred and nineteen pounds out of the Consolidated Revenue Fund, for the purposes and services expressed in the Schedule to this Act, and the Treasurer is hereby authorized and empowered to issue and apply the moneys authorized to be issued and applied.

EXCISE TARIFF.

No. 11 of 1902.

An Act relating to Duties of Excise.

[Assented to 26th July, 1902.]

**B**E it enacted by the King's Most Excellent Majesty, the Senate, and the House of Representatives of the Commonwealth of Australia, as follows :—

Short title

1. This Act may be cited as the *Excise Tariff* 1902.

Incorporation.

2. The *Distillation Act* 1901, the *Beer Excise Act* 1901, and the *Excise Act* 1901 shall be incorporated and read as one with this Act.

Definitions.

3. In this Act, except where otherwise clearly intended—

“Tariff” means the Tariff proposed in the Parliament on the eighth day of October One thousand nine hundred and one.

“Tariff alteration” means any alteration of the Tariff since proposed in the Parliament.

Time of

uniform Duties  
of Excise.

4. The time of the imposition of uniform Duties of Excise is the eighth day of October One thousand nine hundred and one at four o'clock in the afternoon reckoned according to the standard time in force in the State of Victoria, and this Act shall be deemed to have come into operation at that time.

Duties of  
Excise.

5. The Duties of Excise specified in the Schedule are hereby imposed according to the Schedule, as from the time of the imposition of uniform Duties of Excise and such other later dates as are mentioned in the Schedule in regard to any particular items, and such
