

Persons entitled to vote.

3. Subject to the disqualifications hereafter set out, all persons not under twenty-one years of age whether male or female married or unmarried—

- (a) Who have lived in Australia for six months continuously, and
- (b) Who are natural born or naturalized subjects of the King, and
- (c) Whose names are on the Electoral Roll for any Electoral Division,

shall be entitled to vote at the election of Members of the Senate and the House of Representatives.

Disqualifications.

See sec. 44 sub-sec. ii. of the Constitution.

4. No person who is of unsound mind and no person attainted of treason, or who has been convicted and is under sentence or subject to be sentenced for any offence punishable under the law of any part of the King's dominions by imprisonment for one year or longer, shall be entitled to vote at any election of Members of the Senate or the House of Representatives.

Disqualification of coloured races.

No aboriginal native of Australia Asia Africa or the Islands of the Pacific except New Zealand shall be entitled to have his name placed on an Electoral Roll unless so entitled under section forty-one of the Constitution.

One adult one vote.

See s. 30 of the Constitution.

5. No person shall be entitled to vote more than once at the same election.

CONSOLIDATED REVENUE.

No. 9 of 1902.

An Act to grant and apply out of the Consolidated Revenue Fund the sum of Four hundred and forty-eight thousand eight hundred and eighty-two pounds to the service of the year ending the thirtieth day of June One thousand nine hundred and two.

[Assented to 19th June, 1902.]

Preamble.

BE it enacted by the King's Most Excellent Majesty, the Senate, and the House of Representatives of the Commonwealth of Australia for the purpose of appropriating the grant originated in the House of Representatives as follows:—

Issue and application of £448,882.

1. There shall and may be issued and applied for or towards making good the supply hereby granted to His Majesty for the service of the year ending the thirtieth day of June One thousand nine

hundred and two the sum of Four hundred and forty-eight thousand eight hundred and eighty two pounds out of the Consolidated Revenue Fund, for the purposes and services expressed in the Schedule to this Act, and the Treasurer is hereby authorized and empowered to issue and apply the moneys authorized to be issued and applied.

2. The said sum shall be available to satisfy the warrants under the hand of the Governor-General in respect of any purposes and services set forth in the said Schedule.

CONSOLIDATED REVENUE.

No. 10 of 1902.

An Act to grant and apply out of the Consolidated Revenue Fund the sum of Five hundred and eighty-seven thousand two hundred and nineteen pounds to the service of the year ending the thirtieth day of June One thousand nine hundred and three.

[Assented to 23rd June, 1902.]

BE it enacted by the King's Most Excellent Majesty, the Senate, and the House of Representatives of the Commonwealth of Australia for the purpose of appropriating the grant originated in the House of Representatives as follows :—

Preamble.

1. There shall and may be issued and applied for or towards making good the supply hereby granted to His Majesty for the service of the year ending the thirtieth day of June One thousand nine hundred and three the sum of Five hundred and eighty-seven thousand two hundred and nineteen pounds out of the Consolidated Revenue Fund, for the purposes and services expressed in the Schedule to this Act, and the Treasurer is hereby authorized and empowered to issue and apply the moneys authorized to be issued and applied.
