Employment of telegraph messengers.

4. After section thirty-two of the Principal Act the following section is inserted :---

"32A.—(1.) Every person employed as a telegraph messenger shall, on attaining the age of eighteen years, cease to be employed in the Public Service unless he has passed the prescribed examination before attaining that age.

"(2.) Every person employed as a telegraph messenger who has passed the prescribed examination before attaining the age of eighteen years may be allowed to continue in the Public Service as a telegraph messenger until he attains the age of twenty years, but he shall cease to be employed in the Public Service on attaining that age unless he has been previously transferred or promoted to some other office or position in the Public Service.

"(3.) An examination of telegraph messengers under this section shall be held annually.

"(4.) Section ten of the *Post and Telegraph Act* 1901 is repealed.

"(5.) This section shall be deemed to have commenced on the first day of July, One thousand nine hundred and nine.

"(6:) Sub-sections (2) and (3) of this section shall apply only to telegraph messengers who attain the age of eighteen years before the first day of January, One thousand nine hundred and eleven."

## AUSTRALIAN INDUSTRIES PRESERVATION.

## No. 26 of 1909.

An Act to amend the Australian Industries Preservation Acts 1906-1907.

[Assented to 13th December, 1909.]

B<sup>E</sup> it enacted by the King's Most Excellent Majesty, the Senate, and the House of Representatives of the Commonwealth of Australia, as follows :--

1.—(1.) This Act may be cited as the Australian Industries Preservation Act 1909. 1909.

(2.) The Australian Industries Preservation Act 1906, as amended by the Australian Industries Preservation Act 1907, is in this Act referred to as the Principal Act.

(3.) The Principal Act, as amended by this Act, may be cited as the Australian Industries Preservation Act 1906-1909.

2. This Act shall commence on a day to be fixed by Proclamation.\* Commencement.

## PART II.—REPRESSION OF MONOPOLIES.

**3**. Section five of the Principal Act is repealed.

4. Section six of the Principal Act is amended by omitting the Amendment of words "the last two preceding sections," and inserting in lieu Act. thereof the words "section four of this Act".

5. After section seven of the Principal Act the following sections are inserted :---

"7A.-(1.) Any person who, in relation to trade or commerce Unfair concessions by with other countries or among the States, either as principal or persons. agent, in respect of dealings in any goods or services gives offers or promises to any other person any rebate, refund, discount, concession or reward, for the reason, or upon the condition express or implied, that the latter person-

- (a) deals, or has dealt, or will deal, or intends to deal, exclusively with any person, either in relation to any particular goods or services or generally; or
- (b) deals, or has dealt, or will deal, or intends to deal, exclusively with members of a Commercial Trust, either in relation to any particular goods or services or generally; or
- (c) does not deal, or has not dealt, or will not deal, or does not intend to deal, with certain persons, either in relation to any particular goods or services or generally; or

(d) is or becomes a member of a Commercial Trust,

is guilty of an offence.

Penalty: Five hundred pounds.

"(2.) Every contract made or entered into in contravention of this section shall be absolutely illegal and void.

"(3.) It shall be a defence to a prosecution under this section, and an answer to an allegation that a contract was made or entered into in contravention of this section, if the party alleged to have contravened this section proves that the matter or thing alleged to have been done in contravention of this section was not to the detriment of the public, and did not constitute competition which was unfair in the circumstances.

"7B. Any person who, in relation to trade and commerce with Improper The refusals to sell other countries or among the States, either as principal or agent, by persons. refuses either absolutely or except upon disadvantageous conditions

to sell or supply to any other person any goods or services for the reason that the latter person-

- (a) deals, or has dealt, or will deal, or intends to deal, with any person; or
- (b) deals, or has dealt, or will deal, or intends to deal, with persons who are not members of a Commercial Trust; or

(c) is not a member of a Commercial Trust,

is guilty of an offence.

Penalty: Five hundred pounds."

Repeal of s. 8 of Principal Act.

6. Section eight of the Principal Act is repealed.

7. After section ten of the Principal Act the following section is inserted :---

"10A.—(1.) Any person who does any act or thing in disobedience of an injunction granted under this part of this Act shall be guilty of an offence.

Penalty: Five hundred pounds for each day during which the offence continues.

"(2.) This section shall not be deemed to derogate from the power of the High Court, apart from this section, to enforce obedience to the injunction."

8. Section ten of the Principal Act is amended by omitting the words "except in the case of foreign corporations, or trading or financial corporations formed within the Commonwealth,".

9. Sub-section (1.) of section thirteen of the Principal Act is repealed and the following sub-section substituted in lieu thereof:---

"(1.) Proceedings for the recovery of pecuniary penalties for offences against this Part of this Act (other than indictable offences or offences against section fifteen B. section fifteen c, or section fifteen E) shall be instituted in the High Court by way of civil action and shall be tried before a Justice of that Court without a jury."

10. Section fourteen of the Principal Act is amended—

- (a) by omitting from sub-section (1.) the words "criminal proceeding" and inserting in lieu thereof the words "proceeding for an indictable offence or for the recovery of penalties"; and
- (b) by omitting from sub-section (2.) the word "civil" and inserting in lieu thereof the word "other".

11. Section fifteen of the Principal Act is amended by omitting the words "or section five."

**12.** Section fifteen A of the Principal Act is amended—
