# NEW GUINEA LOAN GUARANTEE.

#### No. 16 of 1938.

### An Act to provide a Guarantee by the Commonwealth in respect of a Loan to be raised by the Administrator of the Territory of New Guinea to meet the Cost of certain Road Construction.

[Assented to 5th July, 1938.]

[Date of commencement, 2nd August, 1938.]

BE it enacted by the King's Most Excellent Majesty, the Senate, and the House of Representatives of the Grand and the House of Representatives of the Commonwealth of Australia, as follows :---

1. This Act may be cited as the New Guinea Loan Guarantee Act Short title. 1938.

2.—(1.) Subject to this section, the Commonwealth hereby Guarantee of loan raised by guarantees the repayment of, and the payment of interest upon, a Administrator of New Guines. loan not exceeding One hundred and fifty thousand pounds to be raised by the Administrator of the Territory of New Guinea acting under the authority of a law in force in the Territory.

(2.) The last preceding sub-section shall not apply unless—

- (a) the loan is raised at such time and in accordance with such terms and conditions as are approved by the Treasurer; and
- (b) the loan is raised for the purposes of, and the proceeds of the loan are applied to, the construction of a road between Salamaua and Wau in the Territory of New Guinea.

3. The Consolidated Revenue Fund is hereby appropriated to Appropriation. the extent necessary to meet any liability of the Commonwealth arising from the guarantee provided by this Act.

### CENSUS AND STATISTICS.

#### No. 17 of 1938.

### An Act to amend the Census and Statistics Act 1905-1930.

[Assented to 5th July, 1938.] E it enacted by the King's Most Excellent Majesty, the Senate, and the House of Representatives of the Commonwealth of Australia, as follows :---

1.-(1.) This Act may be cited as the Census and Statistics Act short title 1938.and citation.

(2.) The Census and Statistics Act 1905-1930\* is in this Act referred to as the Principal Act.

(3.) The Principal Act, as amended by this Act, may be cited as the Census and Statistics Act 1905–1938.

Commencement.

Statistics to be collected.

Forms to be filled up. 2. This Act shall come into operation on the day on which it receives the Royal Assent.

**3**. Section sixteen of the Principal Act is amended by inserting after the word "collect," the words "at least".

4. Section seventeen of the Principal Act is amended by inserting after the word "form," (first occurring) the words "or, in the case of statistics in relation to any matter specified in paragraph (g) of the last preceding section, in accordance with the instructions contained in or accompanying a form approved by the Minister,".

## DAIRY PRODUCE EXPORT CONTROL.

#### No. 18 of 1938.

### An Act to amend the *Dairy Produce Export Control Act* 1924-1937.

[Assented to 5th July, 1938.]

[Date of commencement, 2nd August, 1938.]

B<sup>E</sup> it enacted by the King's Most Excellent Majesty, the Senate, and the House of Representatives of the Commonwealth of Australia, as follows :—

1.--(1.) This Act may be cited as the Dairy Produce Export Control Act 1938.

(2.) The Dairy Produce Export Control Act 1924-1937\* is in this Act referred to as the Principal Act.

(3.) The Principal Act, as amended by this Act, may be cited as the *Dairy Produce Export Control Act* 1924–1938.

2.—(1.) Section four of the Principal Act is amended—

- (a) by omitting paragraph (b) of sub-section (2.) and inserting in its stead the following paragraph :—
  - "(b) one member who shall be appointed by the Governor-General upon the nomination of the Australian Council of The Australian Institute of Dairy Factory Managers and Secretaries;";

(b) by omitting from sub-section (5.) the letter "(b),";

(c) by omitting from sub-section (5A.) the letter "(b),"; and
