## LOAN (HOUSIVG).

## No. 21 of 1950.

An Act to authorize the Raising of Moneys to be advanced to the States for the purposes of Housing.
[Assented to 9th November, 1950.]
[Date of commencement, 7th Beceiaber, 1950.]

BE it enacted by the King's Most Excellent Majesty, the Senate, and the House of Representatives of the Commonwealth of Australia, as follows :-

1. This Act may be cited as the Loan (Housing) Act 1950.
2. The Treasurer may, from time to time, under the provisions of the Commonwealth Inscribed Stock Act 1911-1946, or under the provisions of any Act authorizing the issue of Treasury Bills, borrow moneys not exceeding in the whole the sum of Twenty-six million pounds.
3. Moneys borrowed under this Act shall be issued and applied only for the expenses of borrowing and for making advances to the States for the purposes of housing in pursuance of the agreement the execution of which is authorized by the Commonwealth and State Housing Agreement Act 1945.

## CUSTOMS TARIFF.

## No. 22 of 1950.

## An Act relating to Duties of Customs. [Assented to 11th November, 1950.]

BE it enacted by the King's Most Excellent Majesty, the Senate, . and the House of Representatives of the Commonwealth of Australia, as follows :-
(2.) The Customs Tariff 1933-1949* is in this Act referred to as the Principal Act.
(3.) The Principal Act, as amended by this Act, may be cited as the Customs Tariff 1933-1950.

## Amendment

 of Tariff.Time of imposition of duties.

Validation of Proclamations.
2. The Schedule to the Principal Act is amended as set out in the Schedule to this Act and duties of Customs are hereby imposed in accordance with the first-mentioned Schedule as amended by the last-mentioned Schedule.
3.--(1.) The tince of the imposition of the duties of Customs (not being duties of Customs the time of the imposition of which is fixed by the next succeeding sub-section) imposed by this Act is the twelfth day of May, One thousand nine hundred and fifty, at nine o'clock in the forenoon, reckoned according to standard time in the Australian Capital Territory, and this Act shall be deemed to have come into operation at that time.
(2.) The time of the inposition of the cluties of Customs imposed by this Act and set out in the column headed "Intermediate Tariff" in the Schedule to this Act, upon any goods which are specified in, and are the produce or manufacture of any British or foreign country specified in, a Proclamation issued on or after the eleventh day of May, One thousand nine hundred and fifty, and prior to the date on which this Act receives the Royal Assent, applying or varying the application of the rates of duty so set out to those goods, is the time and date specified in that Proclamation.
4.-(1.) Every Proclamation issued on or after the eleventh day of May, One thousand nine hundred and fifty, and prior to the date on which this Act receives the Royal Assent, applying or varying the application of rates of duty set out in the column headed " Intermediate Tariff" in the Schodule to this Act to goods which are specified in, and are the produce or mauufacture of any British or foreign country specified in, the Proclamation, and every Proclamation issued during that period revoking or varying any such Proclamation, shall be deemed to have heen lawfully made.
(2.) The power conferred by sub-section (3.) of section nine a of the Principal Act to issue a Proclamation revoking or varying a Proclamation issued in pursuance of sub-section (1.) of that section includes a power to revoke or vary any Prochamation referred to in the last preceding sub-section.
