E it enacted by the Queen's Most Excellent Majesty, the Senate, and the House of Representatives of the Commonwealth of Australia, as follows:-

## Commence

 ment.1.-(1.) This Act may be cited as the Customs Tariff (Canada Preference) (No. 2) 1963.
(2.) The Customs Tariff (Canada Preference) 1960-1962,* as amended by the Customs Tariff (Canada Preference) 1963, $\dagger$ is in this Act referred to as the Principal Act.
(3.) Section one of the Customs Tariff (Canada Preference) 1963 is amended by omitting sub-section (3.).
(4.) The Principal Act, as amended by this Act, may be cited as the Customs Tariff (Canada Preference) 1960-1963.
2. This Act shall be deemed to have come into operation on the nineteenth day of April, One thousand nine hundred and sixty-three.
3. The Second Schedule to the Principal Act is amended as
