

WINE GRAPES CHARGES.

No. 16 of 1941.

An Act to amend the *Wine Grapes Charges Act* 1929-1937.

[Assented to 7th April, 1941.]

BE it enacted by the King's Most Excellent Majesty, the Senate, and the House of Representatives of the Commonwealth of Australia, as follows :—

Short title
and citation.

1.—(1.) This Act may be cited as the *Wine Grapes Charges Act* 1941.

(2.) The *Wine Grapes Charges Act* 1929-1937*, as amended by this Act, may be cited as the *Wine Grapes Charges Act* 1929-1941.

Commencement.

2. This Act shall come into operation on the day on which it receives the Royal Assent.

Definitions.

3. Section two of the *Wine Grapes Charges Act* 1929-1937 is amended by inserting in the definition of "use in the manufacture of wine", after the word "includes", the words "use in the manufacture of brandy or concentrated grape juice and also includes".

CUSTOMS TARIFF VALIDATION.

No. 17 of 1941.

An Act to provide for the Validation of Collections of Duties of Customs under Customs Tariff Proposals.

[Assented to 7th April, 1941.]

BE it enacted by the King's Most Excellent Majesty, the Senate, and the House of Representatives of the Commonwealth of Australia, as follows :—

Short title.

1. This Act may be cited as the *Customs Tariff Validation Act* 1941.

2. This Act shall come into operation on the day on which it receives the Royal Assent. Commencement.

3. All duties of Customs demanded or collected (whether before or after the commencement of this Act and on or before the third day of July, One thousand nine hundred and forty-one) pursuant to the Customs Tariff Proposals introduced into the House of Representatives on the twenty-first day of November, One thousand nine hundred and forty, and on the eleventh day of December, One thousand nine hundred and forty, shall be deemed to have been lawfully imposed and lawfully demanded or collected. Validation of collections under Customs Tariff Proposals.

4. Where, in respect of any goods covered by any item or portion of an item in the Customs Tariff Proposals introduced into the House of Representatives on the eleventh day of December, One thousand nine hundred and forty, it is provided that duties of Customs shall be imposed on and after a date to be fixed by Proclamation, all such duties of Customs demanded or collected on or after the date so fixed and on or before the third day of July, One thousand nine hundred and forty-one shall be deemed to have been lawfully imposed and lawfully demanded or collected. Imposition of duties of Customs by Proclamation.

CUSTOMS TARIFF (EXCHANGE ADJUSTMENT) VALIDATION.

No. 18 of 1941.

An Act to provide for the Validation of Adjustments in Duties of Customs under Customs Tariff (Exchange Adjustment) Proposals.

[Assented to 7th April, 1941.]

BE it enacted by the King's Most Excellent Majesty, the Senate, and the House of Representatives of the Commonwealth of Australia, as follows:—

1. This Act may be cited as the *Customs Tariff (Exchange Adjustment) Validation Act 1941.* Short title.
