5. Section eight of the Principal Act is amended—

- (a) by inserting, after the word "person" (second occurring), the words "or of any attempt to commit such a crime,";
- (b) by inserting, after the words "expiration of", the words " , or during,"; and
- (c) by omitting the words "be required to pass the dictation test, and if he fails to do so shall be deemed to be a prohibited immigrant and shall".

Deportation of  
certain persons.

6. Section eight A of the Principal Act is amended by omitting from sub-section (1.) the word "three" and inserting in its stead the word "five".

7. After section eight B of the Principal Act the following section is inserted :—

Dependants of  
deportee.

"8BA. Where an order has been made under this Act for the deportation of any person, the wife and dependent children of that person may, if the wife so desires, be included in the order for deportation and thereupon the provisions of this Act relating to deportation shall apply to the wife and dependent children."

Duty to  
provide return  
passages.

8. Section thirteen A of the Principal Act is amended by omitting from sub-section (1.) the words "or eight AB" and inserting in their stead the words "eight AB or eight BA".

9. After section fourteen B of the Principal Act the following section is inserted :—

Arrest of  
persons liable  
to deportation.

"14c. Every officer may, without warrant, arrest any person reasonably supposed to be a person whose deportation has been ordered by the Minister in pursuance of this Act, and no person shall resist or prevent such arrest.

Penalty: One hundred pounds or imprisonment for six months."

## An Act to amend the *Forestry Bureau Act* 1930.

[Assented to 30th May, 1932.]

**B**E it enacted by the King's Most Excellent Majesty, the Senate, and the House of Representatives of the Commonwealth of Australia, as follows :—

Short title and  
citation.

1.—(1.) This Act may be cited as the *Forestry Bureau Act* 1932.

(2.) The *Forestry Bureau Act* 1930\* is in this Act referred to as the Principal Act.

(3.) The Principal Act, as amended by this Act, may be cited as the *Forestry Bureau Act 1930-1932*.

2. Section two of the Principal Act is amended by omitting from the definition of "the Territories" the words "Central Australia, North Australia" and inserting in their stead the words "the Northern Territory". Definition.

3. Section seven of the Principal Act is amended by omitting the words "Home Affairs" and inserting in their stead the words "the Interior". Trustees.

## SOLAR OBSERVATORY FUND.

No. 28 of 1932.

### An Act to amend the *Solar Observatory Fund Act 1930-1931*.

[Assented to 30th May, 1932.]

**B**E it enacted by the King's Most Excellent Majesty, the Senate, and the House of Representatives of the Commonwealth of Australia, as follows:—

1.—(1.) This Act may be cited as the *Solar Observatory Fund Act 1932*. Short title and citation.

(2.) The *Solar Observatory Fund Act 1930-1931\** is in this Act referred to as the Principal Act.

(3.) The Principal Act, as amended by this Act, may be cited as the *Solar Observatory Fund Act 1930-1932*.

2. Section five of the Principal Act is amended by omitting the words "Home Affairs" and inserting in their stead the words "the Interior". Trustees.
