An Act to make interim provision for the appropriation of moneys out of the Consolidated Revenue Fund for certain expenditure in respect of the year ending on the thirtieth day of June. One thousand nine hundred and seventy-two.

BE it enacted by the Queen's Most Excellent Majesty, the Senate, and the House of Representatives of the Commonwealth of Australia, as follows:--

1. This Act may be cited as the Supply Act (No. 2) 1971-72.

Short title.

2. This Act shall come into operation on the day on which it receives commencethe Royal Assent.

3.—(1.) The Treasurer may issue out of the Consolidated Revenue Issue, application and Fund and apply for the services specified in the Schedule to this Act in appropriation of \$313,554,000. respect of the financial year ending on the thirtieth day of June, One thousand nine hundred and seventy-two, the sum of Three hundred and thirteen million, five hundred and fifty-four thousand dollars.

(2.) The Consolidated Revenue Fund is appropriated to the extent necessary for the purposes of the last preceding sub-section.
