SUPPLEMENTARY APPROPRIATION (WORKS AND BUILDINGS) 1937-38.

No. 42 of 1939.

An Act to appropriate a further sum out of the Consolidated Revenue Fund for the service of the year ended the thirtieth day of June, One thousand nine hundred and thirty-eight, for the purposes of Additions, New Works, Buildings, &c.

[Assented to 27th September, 1939.]

[Date of commencement 25th October, 1939.]

BE it enacted by the King's Most Excellent Majesty, the Senate, and the House of Representatives of the Commonwealth of Australia, for the purpose of appropriating the grant originated in the House of Representatives, as follows:—

Preamble.

1. This Act may be cited as the *Supplementary Appropriation (Works and Buildings) Act 1937-38.*

Short title.

2. The sum of Three hundred and ninety-four thousand nine hundred and two pounds which has been issued from the Consolidated Revenue Fund for the service of the year ended the thirtieth day of June, One thousand nine hundred and thirty-eight, shall be deemed to have been appropriated as from the date of the commencement of the *Appropriation (Works and Buildings) Act 1937-38* for the purposes and services expressed in the Schedule to this Act.

JUDICIARY.

No. 43 of 1939.

An Act to amend the *Judiciary Act 1903-1937*.

[Reserved for His Majesty's pleasure, 9th September, 1939.]

[Royal Assent proclaimed, 23rd November, 1939.]

BE it enacted by the King's Most Excellent Majesty, the Senate, and the House of Representatives of the Commonwealth of Australia, as follows:—

Short title and citation.

1.—(1.) This Act may be cited as the *Judiciary Act 1939*.

(2.) The *Judiciary Act 1903-1937** is in this Act referred to as the Principal Act.

(3.) The Principal Act, as amended by this Act, may be cited as the *Judiciary Act 1903-1939*.

Original jurisdiction conferred.

2. Section thirty of the Principal Act is amended—

(a) by adding at the end of paragraph (a) the word "and";
and

(b) by omitting paragraph (b).

3. Section thirty A of the Principal Act is repealed.

Repeal of Section 30A.
