

STATES LOAN.

No. 35 of 1926.

An Act to amend the *States Loan Act 1925*.

[Assented to 11th August, 1926.]

BE it enacted by the King's Most Excellent Majesty, the Senate, and the House of Representatives of the Commonwealth of Australia, as follows :—

1.—(1.) This Act may be cited as the *States Loan Act 1926*.

Short title and
citation.

(2.) The *States Loan Act 1925** is in this Act referred to as the Principal Act.

(3.) The Principal Act, as amended by this Act, may be cited as the *States Loan Act 1925-1926*.

2. Section two of the Principal Act is amended by omitting the words "One thousand nine hundred and twenty-six" (wherever occurring) and inserting in their stead the words "One thousand nine hundred and twenty-seven".

3. Section six of the Principal Act is amended by omitting the words "One thousand nine hundred and twenty-six" and inserting in their stead the words "One thousand nine hundred and twenty-seven".

SHALE OIL BOUNTY.

No. 36 of 1926.

An Act to amend the *Shale Oil Bounty Act 1917-1923*.

[Assented to 11th August, 1926.]

BE it enacted by the King's Most Excellent Majesty, the Senate, and the House of Representatives of the Commonwealth of Australia, for the purpose of appropriating the grant originated in the House of Representatives, as follows :—

Preamble.

1.—(1.) This Act may be cited as the *Shale Oil Bounty Act 1926*.

and citation.

(2.) The *Shale Oil Bounty Act* 1917-1923* is in this Act referred to as the Principal Act.

(3.) The Principal Act, as amended by this Act, may be cited as the *Shale Oil Bounty Act* 1917-1926.

2. Section two of the Principal Act is amended by omitting the words "nine years" and inserting in their stead the words "twelve years".

Specification
of bounty.

3. Section three of the Principal Act is amended by omitting the words "nine years" and inserting in their stead the words "twelve years".

Amendment
of Schedule.

4. The Schedule to the Principal Act is amended—

- (a) by omitting from the second column the figure "9" and inserting in its stead the figures "12"; and
- (b) by omitting from the fourth column the figures "1926" and inserting in their stead the figures "1929".

An Act to amend section fifteen of the *Commerce (Trade Descriptions) Act* 1905.

BE it enacted by the King's Most Excellent Majesty, the Senate, and the House of Representatives of the Commonwealth of Australia, as follows:—

1.—(1.) This Act may be cited as the *Commerce (Trade Descriptions) Act* 1926.

(2.) The *Commerce (Trade Descriptions) Act* 1905,* as amended by this Act, may be cited as the *Commerce (Trade Descriptions) Act* 1905-1926.

Application of
sections 7 and
11.

2. Section fifteen of the *Commerce (Trade Descriptions) Act* 1905 is amended by adding at the end thereof the following paragraph:—

" ; or (g) brushware."
