

## SALES TAX (NO. 4).

## No. 48 of 1952.

An Act to amend the *Sales Tax Act (No. 4)*  
1930-1951.

[Assented to 30th September, 1952.]

**B**E it enacted by the Queen's Most Excellent Majesty, the Senate, and the House of Representatives of the Commonwealth of Australia, as follows :—

Short title and citation.	1.—(1.) This Act may be cited as the <i>Sales Tax Act (No. 4)</i> 1952. (2.) The <i>Sales Tax Act (No. 4)</i> 1930-1951*, as amended by this Act, may be cited as the <i>Sales Tax Act (No. 4)</i> 1930-1952.
Commencement.	2. This Act shall be deemed to have come into operation on the seventh day of August, One thousand nine hundred and fifty-two.
Imposition of tax.	3. Sections three and four of the <i>Sales Tax Act (No. 4)</i> 1930-1951 are repealed and the following sections inserted in their stead :— “ 3. Sales tax is imposed, at the rates specified in the next succeeding section, upon the sale value of goods manufactured in Australia and sold to a taxpayer who has, on or after the seventh day of August, One thousand nine hundred and fifty-two, applied those goods to his own use.
Rates of tax.	“ 4. The rates of the sales tax imposed by this Act are— (a) in respect of goods covered by the Second Schedule to the <i>Sales Tax (Exemptions and Classifications) Act</i> 1935-1952—20 per centum ; (b) in respect of goods covered by the Third Schedule to the <i>Sales Tax (Exemptions and Classifications) Act</i> 1935-1952—33½ per centum ; (c) in respect of goods covered by the Fourth Schedule to the <i>Sales Tax (Exemptions and Classifications) Act</i> 1935-1952—50 per centum ; and (d) in respect of goods not covered by the Second, Third or Fourth Schedule to the <i>Sales Tax (Exemptions and Classifications) Act</i> 1935-1952 and on the sale value of which it is not provided by that Act that the sales tax imposed by this Act shall not be payable—12½ per centum.”
Savings.	4. The sales tax imposed by the provisions repealed by this Act upon the sale value of goods manufactured in Australia and sold to a taxpayer who has, on or after the twenty-seventh day of September, One thousand nine hundred and fifty-one, and before the date of commencement of this Act, applied those goods to his own use continues to be imposed as if those provisions had not been repealed.
