## Seamen's War Pensions and Allowances

## No. 18 of 1971

An Act to amend the Seamen's War Pensions and Allowances Act 1940-1970 so as to provide for Increases in the Rates of certain Pensions.

[Assented to 7 April 1971]

BE it enacted by the Queen's Most Excellent Majesty, the Senate, and the House of Representatives of the Commonwealth of Australia, as follows:-

Short title and citation.

- 1.—(1.) This Act may be cited as the Seamen's War Pensions and Allowances Act 1971.
- (2.) The Seamen's War Pensions and Allowances Act 1940-1970\* is in this Act referred to as the Principal Act.
- (3.) The Principal Act, as amended by this Act, may be cited as the Seamen's War Pensions and Allowances Act 1940-1971.

Commencement.

- 2. This Act shall be deemed to have come into operation on the first day of April, One thousand nine hundred and seventy-one.
- Rates of pension on death or total incapacity.
- 3. Section 18 of the Principal Act is amended by omitting from subsection (4A.) the words "Fifty-six dollars" and inserting in their stead the words "Fifty-seven dollars".

4. The First Schedule to the Principal Act is repealed and the following Schedule inserted in its stead:-

In so far as an amendment made by this Act affects instalments of Application of amendments. pensions, the amendment applies in relation to an instalment of a pension falling due on the pension pay day immediately following the last pension pay day before the date of commencement of this Act and to all subsequent instalments.
