Tractor Bounty

No. 15 of 1966

An Act to amend the Tractor Bounty Act 1939–1959.

[Assented to 18 May, 1966]

BE it enacted by the Queen's Most Excellent Majesty, the Senate, and the House of Representatives of the Commonwealth of Australia, as follows:—

1.—(1.) This Act may be cited as the Tractor Bounty Act 1966. Short title

- (2.) The Tractor Bounty Act 1939-1959* is in this Act referred to as the Principal Act.
- (3.) The Principal Act, as amended by this Act, may be cited as the Tractor Bounty Act 1939-1966.
- 2. This Act shall come into operation on the day on which it Commencereceives the Royal Assent.

3. Section 6 of the Principal Act is amended by omitting specification of bounty. from sub-section (2.) the words "the thirtieth day of June, One thousand nine hundred and sixty-six" and inserting in their stead
