## Tractor Bounty

No. 15 of 1966
An Act to amend the Tractor Bounty Act 1939-1959.
[Assented to 18 May, 1966]
$\mathbf{B}^{E}$ it enacted by the Queen's Most Excellent Majesty, the Senate, and the House of Representatives of the Commonwealth of Australia, as follows:-
1.-(1.) This Act may be cited as the Tractor Bounty Act 1966.
(2.) The Tractor Bounty Act 1939-1959* is in this Act referred to as the Principal Act.
(3.) The Principal Act, as amended by this Act, may be cited as the Tractor Bounty Act 1939-1966.
2. This Act shall come into operation on the day on which it receives the Royal Assent.
3. Section 6 of the Principal Act is amended by omitting from sub-section (2.) the words " the thirtieth day of June, One
