### COLONIAL LIGHT DUES APPROPRIATION.

#### No. 67 of 1932.

## An Act relating to Colonial Light Dues.

[Assented to 5th December, 1932.]

Preamble.

BE it enacted by the King's Most Excellent Majesty, the Senate, and the House of Representatives of the Commonwealth of Australia. for the purpose of appropriating the grant originated in the House of Representatives, as follows:—

Short title.

1. This Act may be cited as the Colonial Light Dues Appropriation Act 1932.

Appropriation.

- 2.—(1.) There shall be payable to the Government of the United Kingdom such amounts as are, from time to time, received by the Commonwealth under the Colonial Light Dues Collection Act 1932 in payment of Colonial light dues.
- (2.) Any amounts payable to the Government of the United Kingdom under this section shall be paid out of the Consolidated Revenue Fund which is, to the necessary extent, hereby appropriated accordingly.

# WAR SERVICE HOMES (No. 2).

### No. 68 of 1932.

An Act to amend section twenty-nine of the War Service Homes Act 1918-1929 as amended by the War Service Homes Act 1932.

[Assented to 5th December, 1932.]

BE it enacted by the King's Most Excellent Majesty, the Senate, and the House of Representatives of the Commonwealth of Australia, as follows:—

Short title and citation.

- 1.—(1.) This Act may be cited as the War Service Homes Act (No. 2) 1932.
- (2.) The War Service Homes Act 1918-1929, as amended by the War Service Homes Act 1932, is in this Act referred to as the Principal Act.
- (3.) Sub-section (3.) of section one of the War Service Homes Act 1932 is repealed.
- (4.) The Principal Act, as amended by this Act, may be cited as the War Service Homes Act 1918-1932.

- 2. This Act shall be deemed to have commenced on the first day commencement. of August One thousand nine hundred and thirty-two.
  - 3. Section twenty-nine of the Principal Act is amended—

Purchase money

- (a) by omitting from sub-section (1.) all the words after the or advance—how payable or words "provided that" (first occurring) and inserting in their stead the words "the period over which such instalments are repayable shall not exceed fifty years in the case of the widow or widowed mother of an Australian soldier or forty-five years in other cases."; and
- (b) by adding after sub-section (1.) the following sub-section:—
- "(1A.) The Commissioner may, with the consent of the purchaser or borrower, vary the contract entered into, or mortgage executed, by the purchaser or borrower, so as to extend the period of repayment and to reduce the amount of each instalment:

Provided that the period so extended shall not exceed the maximum period prescribed by this section.".

## INVALID AND OLD-AGE PENSIONS APPROPRIATION (No. 2).

### No. 69 of 1932.

An Act to grant and apply out of the Consolidated Revenue Fund a sum for Invalid and Old-age Pensions.

[Assented to 5th December, 1932.]

BE it enacted by the King's Most Excellent Majesty, the Senate, Preamble. and the House of Representatives of the Commonwealth of Australia, for the purpose of appropriating the grant originated in the House of Representatives, as follows:-

- 1. This Act may be cited as the Invalid and Old-age Pensions short utle. Appropriation Act (No. 2) 1932.
- 2. There shall be payable out of the Consolidated Revenue Fund, Appropriation which is hereby appropriated accordingly, for the purposes of the for invalid and Trust Account established under the Audit Act 1901–1926, and known old-age pensions. as the Invalid and Old-age Pensions Fund, the sum of Ten million pounds for invalid and old-age pensions.
