An Ordinance to amend the Lottery and Gaming Ordinance 1940–1966

[Assented to 18 June, 1968]

BE it ordained by the Legislative Council for the Northern Territory of Australia, in pursuance of the powers conferred by the Northern Territory (Administration) Act 1910-1968, as follows:—

Short title and citation

- 1.—(1.) This Ordinance may be cited as the Lottery and Gaming Ordinance 1968.
- (2.) The Lottery and Gaming Ordinance 1940-1966 is in this Ordinance referred to as the Principal Ordinance.
- (3.) The Principal Ordinance, as amended by this Ordinance, may be cited as the *Lottery and Gaming Ordinance* 1940-1968.

Commencement

2. This Ordinance shall come into operation on a date to be fixed by the Administrator by notice in the Gazette.*

Betting or wagering prohibited 3. Section 34 of the Principal Ordinance is amended by omitting sub-section (3A.).

Penalty for receiving money as deposit &c. on a bet 4. Section 45 of the Principal Ordinance is amended by inserting in sub-paragraph (i) of paragraph (a) after the word "horse-race" the word ", dog-race".

Penalty for exhibiting placards &c. as to betting

- 5. Section 46 of the Principal Ordinance is amended by omitting from sub-paragraph (i) of paragraph (b) the words "on a licensed race-course on a day on which a race meeting is being held on that race-course," and inserting in their stead the words "on—
 - (A) a licensed race-course on a day on which a race meeting is being held on that race-course; or

(B) a licensed dog-racing ground on a day on which a dog-racing meeting is being held on that dog-racing ground,

as the case may be, that meeting".

6. Section 67 of the Principal Ordinance is amended by inserting after the words "of any horse" the words "or dog".

Ordinance not to extend to stakes payable to winner of lawful game or race Definitions

- 7 Section 75 of the Principal Ordinance is amended—
 (a) by omitting from the definition of "race" the words
 - (a) by omitting from the definition of "race" the words "or pony race" and inserting in their stead the words ", pony race or dog race"; and
 - (b) by omitting the definition of "race-course".
- 8. Section 76 of the Principal Ordinance is amended by omitting the words "race-course at which it holds race meetings" and inserting in their stead the words "licensed race-course or licensed dog-racing ground at which it holds race meetings or dog-racing meetings".

Applications for licences

9 Section 77 of the Principal Ordinance is amended by omitting from sub-section (3.) the word "race-course" and inserting in its stead the words "licensed race-course or licensed dog-racing ground".

Totalizator

10. Section 83 of the Principal Ordinance is amended—

Application of revenue from totalizator

(a) by omitting from paragraph (d) of sub-section (1.) the words "the race-course" and inserting in their stead the words "the licensed race-course or the licensed dog-racing ground"; and

(b) by omitting from paragraph (e) of sub-section (1.) the words "and pony racing" and inserting in their stead the words ", pony racing and dog racing".

11. Section 88 of the Principal Ordinance is amended by inserting after the words "race meeting" the words "or dog-racing meeting".

Returns of moneys received through totalizator

12. Section 91 of the Principal Ordinance is amended—

(a) by omitting from paragraph (a) of sub-section (3.) the word "race-course" and inserting in its stead the words "licensed race-course"; and

Inspectors

- (b) by inserting after paragraph (a) of sub-section (3.) the following paragraph:—
 - "(aa) at all times during a dog-racing meeting at which a totalizator is used enter without

charge the licensed dog-racing ground where the dog-racing meeting is being held;".

Hindering Inspectors 13. Section 92 of the Principal Ordinance is amended by omitting the words "race-course" and inserting in its stead the words "licensed race-course, any licensed dog-racing ground".

Restrictions on betting under this Part 14. Section 94B of the Principal Ordinance is amended by inserting after the words "race meeting" the words "or dogracing meeting".

Accounts

15. Section 94k of the Principal Ordinance is amended by inserting in sub-section (4.) after the words "of this Ordinance," the words "and such companies, associations or other bodies of persons established for the purpose of promoting, conducting or controlling the sport of dog-racing,".

No betting except on licensed premises 16. Section 94AD of the Principal Ordinance is amended by adding at the end thereof the words "or on a licensed dog-racing meeting whilst there is in progress a dog-racing meeting at which he is lawfully operating as a registered bookmaker".

Times during which licensed premises may be open for betting

- 17. Section 94AE of the Principal Ordinance is amended—
 - (a) by inserting in sub-section (1.) after the words "a race meeting" the words "or dog-racing meeting";
 - (b) by omitting from paragraph (a) of sub-section (2.) the word "and"; and
 - (c) by adding after paragraph (b) of sub-section (2.) the following word and paragraph:—
 "; and (c) after noon of any day on which a dog-racing meeting is held on a licensed dog-racing ground within fifty miles of the premises".

Licensed bookmaker required to accept bets offered

- 18. Section 94AG of the Principal Ordinance is amended—
 - (a) by inserting in sub-section (1.) after the words "race meeting" the words "or dog-racing meeting"; and
 - (b) by omitting from sub-section (1.) the words "or pony" and inserting in their stead the words ", pony or dog,".

Order forbidding impoverished persons to bet 19. Section 94AN of the Principal Ordinance is amended by omitting from sub-section (4.) the words "or race-course" and inserting in their stead the words ", race-course or dog-racing ground".

- 20. Section 99 of the Principal Ordinance is amended by Regulations omitting the word "Administrator" and inserting in its stead the words "Administrator in Council".
- 21. The Principal Ordinance is amended as set out in the Amendments in relation to decimal currency
