

No. 63 of 1968

An Ordinance to amend the *Stock Diseases Ordinance 1954-1963*

[Assented to 18 September, 1968]

BE it ordained by the Legislative Council for the Northern Territory of Australia, in pursuance of the powers conferred by the *Northern Territory (Administration) Act 1910-1968*, as follows:—

- 1.—(1.) This Ordinance may be cited as the *Stock Diseases Ordinance 1968*. Short title and citation
- (2.) The *Stock Diseases Ordinance 1954-1963* is in this Ordinance referred to as the Principal Ordinance.
- (3.) The Principal Ordinance, as amended by this Ordinance, may be cited as the *Stock Diseases Ordinance 1954-1968*.
2. Section 23 of the Principal Ordinance is amended by inserting in sub-section (1.) after the words “into the Territory” the words “or a part of the Territory”. Prohibition against or restriction of importation of stock
3. Section 41A of the Principal Ordinance is repealed and the following section inserted in its stead:—
 “41A. The Chief Inspector may, by notice in the *Gazette*, prohibit or restrict the use in the treatment of stock of a substance or class of substances.” Restriction on use of specified substances
4. Section 46 of the Principal Ordinance is repealed. Repeal of section 46
5. Section 48 of the Principal Ordinance is amended by omitting the words “The Administrator” and inserting in their stead the words “The Administrator in Council”. Regulations
6. The Principal Ordinance is amended as set out in the Schedule to this Ordinance. Amendments in relation to decimal currency
