AMENDMENT OF THE MOTOR VEHICLE (HIRE CAR) REGULATIONS

1. COMMENCEMENT

These Regulations shall come into operation on a date to be fixed by the Administrator by notice in the Gazette.



For the purposes of this Schedule -

^{&#}x27;flagfall' means the hire charge;

^{&#}x27;Saturday morning' means the period commencing at 6 o'clock in the morning of a Saturday and ending at 1 o'clock in the afternoon of that Saturday;

^{&#}x27;special journey' means a journey for the purpose of a wedding or funeral or other special occasion where the hiring includes waiting until the wedding or funeral or other special occasion has taken place and further carriage of the hirer immediately afterwards;



Motor Vehicle (Hire Car) Regulations

- 'tariff 1' means the distance rate, expressed in metres, that shall be travelled for a charge of 5 cents on a journey which takes place wholly within the taximeter area and on a weekday or Saturday morning;
- 'tariff 2' means the distance rate, expressed in metres, that shall be travelled for a charge of 5 cents on a journey which takes place partly within the taximeter area, or wholly within the taximeter area and during a period not referred to in tariff 1:
- 'waiting time' means the number of seconds that shall elapse before a charge of 5 cents shall be made;
- 'weekday' means a period commencing at 6 o'clock in the morning and ending at 9 o'clock in the evening on a day which is not a Saturday, Sunday or a public holiday.".
