An Act to amend the Laws of the Customs in South Australia.

[Assented to, 18th July, 1860.]

WHEREAS it is expedient to alter the duties of Customs Preamble. imposed in the Province of South Australia in manner hereinafter provided—Be it therefore Enacted, by the Governor-in-Chief of the Province of South Australia, with the advice and consent of the Legislative Council and House of Assembly of the said Province, in this present Parliament assembled, as follows:

- 1. In lieu of and instead of all other duties of Customs, there Duties, shall be raised, levied, collected, and paid unto Her Majesty for the uses of the said Province and support of the Government thereof, the several duties of Customs inserted, described, and set forth in the Schedule hereto annexed, and no other.
- 2. The Collector of Customs, and all Officers of Customs in the Indemnity to Colsaid Province, shall not be liable to and are hereby indemnified and protected against any action, claim, or damages to which he or they might otherwise have been liable by reason of any refusal to deliver any goods imported into the said Province after the twenty-second day of May 1860, or in bond on that day, without payment of the duties by this Act authorized to be levied, or without payment of the duties authorized to be levied by any Act in force within the said Province, at the time of the coming into operation of this Act.

3. The Collector of Customs is hereby authorized to make re- Repayment authorized payment of certain duties.

payment to the importers of goods of such duties as shall have been collected since the hour of half-past two of the clock in the afternoon of the said twenty-second day of May, excepting the duties collected on such goods as are set forth in the Schedule to this Act annexed.
