An Act to amend the Cattle Compensation Act, 1939-1964.

[Assented to 25th November, 1965.]

BE IT ENACTED by the Governor of the State of South Australia, with the advice and consent of the Parliament thereof, as follows:

Short titles.

- 1. (1) This Act may be cited as the "Cattle Compensation Act Amendment Act, 1965".
- (2) The Cattle Compensation Act, 1939-1964, as amended by this Act, may be cited as the "Cattle Compensation Act, 1939-1965".
- (3) The Cattle Compensation Act, 1939-1964, is hereinafter referred to as "the principal Act".

Incorporation.

2. This Act is incorporated with the principal Act and that Act and this Act shall be read as one Act.

Amendment of principal Act, s. 12—

Statements to be made out on sale of cattle and stamps affixed.

- 3. Section 12 of the principal Act is amended—
 - (a) by inserting after the word "cattle" first and second occurring in subsection (1) thereof the words "or the carcasses of cattle" in each case;
 - (b) by inserting after the word "cattle" third occurring in the said subsection (1) thereof the passage "or each carcass, as the case may be";

- (c) by inserting after the word "cattle" twice occurring in paragraph (a) of subsection (1a) thereof the words "or carcasses of cattle or both" in each case;
- (d) by inserting after the word "cattle" in paragraph (g) of the said subsection (Ia) thereof the words "or carcasses of cattle or both";
- (e) by inserting after the word "cattle" in subsection (3) thereof the words "or carcasses of cattle or both".

4. Section 12a of the principal Act is amended—

Amendment of principal Act, s. 12a—

- (a) by inserting after the word "cattle" in subsection (1) Purchasers thereof the words "or carcasses of cattle or both"; duty.
- (b) by striking out the words "sells them" in subsection (3) thereof and inserting in lieu thereof the words "or carcasses of cattle sells them or any of them";
- (c) by inserting after the word "cattle" first occurring in paragraph (a) of the said subsection (3) thereof the words "or carcasses of cattle";
- (d) by inserting after the word "cattle" second occurring in the said paragraph (a) of the said subsection (3) thereof the words "or carcass".

5. Subsection (2) of section 13 of the principal Act is repealed and the following subsection is inserted in the principal Act in 5.13—

Duty on sales of cattle.

(2) For every head of cattle or carcass sold, whether singly or in a lot, there shall be payable a stamp duty of sixpence where the amount of the purchase-money in respect of such head or carcass does not exceed thirty-five pounds and a stamp duty of one shilling where the amount of the purchase-money in respect of such head or carcass exceeds thirty-five pounds.
