An Act to amend the Law for the Registration of Persons entitled

to vote at Elections for Members of the Legislative Council.

[Assented to 19th October, 1853.]

THEREAS it is expedient to amend the existing Law for the Preamble. Registration of Persons entitled to vote at Elections for Members of the Legislative Council—Be it Enacted by the Governor of South Australia, with the advice and consent of the Legislative Council of the same, as follows:

1. So much of an Ordinance passed in the fourteenth year of Repeal of so much of the reign of Her Majesty Queen Victoria, No. 1 of 1851, "To Ordinance No. 1 of 1851, as relates to reestablish the Legislative Council of South Australia, and to provide gistration of voters. for the election of Members to serve in the same," as relates to the forming and revision of electoral lists and the registration of voters shall be, and the same is hereby repealed.

2. Every Returning Officer shall, within four days from the Notice of Court of receipt of a writ for the election of a Member to serve in the Legis- Revision to be given. lative Council for any Electoral District, give public notice of the receipt of such writ, and of the time, being not less than fourteen clear days from the publication of such notice, and place of holding a Court of Revision, and shall cause such notice and also a copy of the existing or last previous electoral roll for such district to be affixed in some accessible and conspicuous place, upon the Court House or place of meeting of the Local Court, if there be any such within the district, and upon such other public buildings within such district as he shall think fit.

3. Within the period of ten days from the publication of such notice, Claims of persons to any person whose name shall not be inserted in such electoral roll, and have their names who shall claim to have his name inserted therein, shall give notice lists. thereof to the Returning Officer in the form of the Schedule to this Act annexed, marked A, or to the like effect; and any person whose name

shall have been inserted, or who shall claim to have his name inserted in such roll, may object to any other person as not entitled to have his name retained in the said electoral roll; and any person so objecting shall, on or before the day so fixed for giving notice of claims, give, or cause to be given, to the Returning Officer, and also to the person objected to, or leave at the premises for which his name shall appear to be inserted in such electoral roll, notice thereof, in writing, according to the form in the Schedule to this Act annexed, marked B, or to the like effect; and the said Returning Officer shall include the names of all persons so claiming to be inserted on the electoral list, in a list according to the form in the Schedule to this Act annexed, marked C; and the names of all persons objected to in a list according to the form of the Schedule to this Act annexed, marked D; and shall cause copies of such several lists to be fixed on the outer doors or walls of the public or conspicuous buildings or places aforesaid, during the four days next preceding the holding of any Court of Revision under the authority hereof; and the said Returning Officer shall likewise keep a list of the names of all persons so claiming as aforesaid, and also a list of the names of all persons so objected to as aforesaid, to be perused by any person without payment of any fee, at all reasonable hours during such four days (Sunday excepted), and shall deliver a copy of each of such lists to any person requiring the same, on payment of a sum not exceeding One Shilling for each copy.

Courts for revision of electoral lists.

4. On such day as shall be named in any notice to be published as aforesaid, the Returning Officer shall, in conjunction with the nearest Special Magistrate and one Justice of the Peace, or with two Justices of the Peace for the said Province, hold an open Court for the revision of the electoral list, and continue such Court by adjournment, and shall, at the opening of the said Court, produce the electoral roll for the time being, and a copy of the lists of the persons so claiming, and of the persons so objected to, made out in the manner aforesaid; and all collectors of rates and others, shall, on being thereto summoned, attend the said Court, and shall answer upon oath all such questions as the said Court may put to them or any of them, touching any matter necessary for revising the electoral lists; and the said Court shall insert in the electoral roll, the name of every person who shall be proved to the satisfaction of the Court to be entitled to be inserted therein, and shall retain on the said roll the names of all persons to whom no objection shall have been duly made, and shall also retain on the said roll the name of every person who shall have been objected to by any person, unless the party so objecting shall appear by himself, or by some one on his behalf, in support of such objection; and when the name of any person inserted on such roll shall have been duly objected to, and the person objecting shall appear by himself, or by some one on his behalf, in support of such objection, the Court shall require proof of the qualification of the person so objected to; and in case the qualification of such person shall not be proved to the satisfaction of the Court, the said Court shall expunge his name from the said

roll, and shall also expunge therefrom the name of every person who shall be proved to the Court to be dead, and shall correct any mistake, or supply any omission which shall be proved to the Court to have been made in any of the said lists, in respect to the name or place of abode of any person who shall be included therein, or in respect of the local description of his property: Provided always, that no person's name shall be inserted by the said Court in any such lists, or shall be expunged therefrom, except in the case of death, unless notice shall have been given, as is hereinbefore required in each of the said cases.

5. The said Court shall have power to require any person Power to the Court to having the custody of any book containing any rate made for any order the production of books and electoral district or any part thereof, during the then current or the administer the oath. preceding year, to produce the said book and allow the same to be inspected, and shall have power to administer oaths or affirmations as the case may be, as well to the clerk and to the collectors, as to all persons claiming to be inserted in, or making objection to the omission or insertion of any name in any of the said lists, and to all persons objected to in any such lists, and to all persons claiming to have any mistake in any such lists corrected, and to all witnesses who may be tendered or examined on either side, by which oath or affirmation the person under examination shall be required to state the truth, the whole truth, and nothing but the truth, relating to the matter in hand, and shall be liable, if he swear or affirm falsely in answer to any lawful question put to him at such examination, to be prosecuted for perjury; and the Returning Officer shall in open Court write his initials against the names struck out or inserted, and against any part of the said lists in which any mistake shall have been corrected, and shall sign his name to every page of the several lists so settled.

6. The Returning Officer shall keep the electoral lists so revised Revised lists to be and signed as aforesaid, and shall cause the same to be fairly and kept by the Returning Officer. truly copied into an alphabetical list in a book to be by him provided for that purpose, leaving such spaces as may be necessary for any Electoral Bill to be subsequent additions thereto; and shall cause such book to be com- corrected. pleted within four days from the holding of the first Court of Revision, and shall cause such book, together with the lists, to be preserved among the records of his office, and shall, within four days after the holding of any Court of Revision subsequent to the first, correct the said book by inserting therein in alphabetical order, or expunging therefrom, the names of persons inserted in or expunged from the electoral list by any such Court, and shall also transmit a copy of such book, and of all corrections to be from time to time made therein, to the Colonial Secretary, and every such book shall be the roll of the electors of the electoral district to which the same relates.

Electoral Place

7. The Returning Officer shall furnish copies of the electoral roll to all persons applying for the same on payment of a reasonable furnish copies of the electoral roll. price for each copy.

Personal attendance of electors not necescation to vote unless required by the Court.

8. No elector claiming to register his vote in any electoral dissary to prove qualifi- trict shall be obliged to appear in person to make proof of the nature and sufficiency of his qualification unless required by the Court at which he shall apply to be registered to attend in person, or unless objected to in manner aforesaid: Provided however, that if such personal attendance be rendered requisite, on the application of any party objecting to a claimant's right to register his vote, such party, if his objection be disallowed, shall defray such expenses as the Court shall award for claimants' attendance, which expenses so awarded shall be recoverable in any Court of competent jurisdiction in which the party entitled thereto shall sue for the same.

Date and issue of

9. No writ for the election of Members to serve in the Legislative Council for any electoral district shall be dated or issued less than twenty-four nor more than forty-two days previous to the day named therein for the holding of the elections.

Returning Officer may appoint parties to receive claims.

10. Any Returning Officer may appoint one or more persons to act for him in receiving such notices of claims and objections, giving public notice in manner aforesaid of every such appointment.

Fees payable to Returning Officer.

11. There shall be payable to every Returning Officer by the Colonial Treasurer, in respect of the matters aforesaid, the sums mentioned in Schedule E to this Act annexed.
