An Act to amend The Inter-State Destitute Persons Relief Act, 1910.

[Assented to, November 12th, 1931.]

BE it Enacted by the Governor of the State of South Australia, with the advice and consent of the Parliament thereof, as follows:

- 1. (1) This Act may be cited as the "Inter-State Destitute Persons Short titles. Relief (Amendment) Act, 1931".
- (2) The Inter-State Destitute Persons Relief Act, 1910 (which No. 1008 of 1910. is hereinafter referred to as "the principal Act"), and this Act may be cited together as the "Inter-State Destitute Persons Relief Acts, 1910 and 1931".
- 2. The definition of "Order" in section 4 of the principal Act is Amendment of 2. The definition of "Order in section 4 of the principal Act is amended by adding at the end thereof the words "The term also Definition of includes an order or judgment for maintenance confirmed under the "order. provisions of any Act reciprocal to the Imperial Act intituled the Maintenance Orders (Facilities for Enforcement) Act, 1920".

3. The definition of "State" in section 4 of the principal Act is Amendment of amended-

(a) by inserting after the word "Commonwealth" in the first line thereof the words "and any territory under the authority of the Commonwealth (including any territory governed by the Commonwealth under a mandate)"; and

(b) by

(b) by inserting after the word "Commonwealth" in the fifth line thereof the words "and any territory under the authority of the Commonwealth (including any territory governed by the Commonwealth under a mandate)".

Amendment of principal Act, s. 5—Reciprocity.

- 4. Section 5 of the principal Act is amended—
 - (a) by striking out the words "in the Commonwealth" in the first line thereof;
 - (b) by inserting after the word "Act" in the first line thereof the words "or law";
 - (c) by striking out the words "in the Commonwealth" in the first line of subsection (2) thereof; and
 - (d) by inserting after the word "Act" in the first line of subsection (2) thereof the words "or law".

Amendment of principal Act, s. 6—Summons for relief.

- 5. Section 6 of the principal Act is amended—
 - (a) by inserting after the word "made" in the eleventh line thereof the words "or confirmed"; and
 - (b) by inserting after the word "granted" in the twentieth line thereof the word "confirmed".

Amendment of principal Act, s. 7—Summons for relief.

- 6. Section 7 of the principal Act is amended—
 - (a) by inserting after the word "made" in the tenth line thereof the words "or confirmed"; and
 - (b) by inserting after the word "made" in the twenty-first line thereof the words "or confirmed".

Amendment of principal Act, s. 14— Application for order for relief.

- 7. Section 14 of the principal Act is amended—
 - (a) by inserting after the word "made" wherever it occurs in the third and seventh lines thereof in every case the words "or confirmed":
 - (b) by striking out the words "in any case, being made in favor of any person resident in such State" in paragraph 1. of subsection (1) thereof.

Amendment of principal Act, s. 15— Endorsement. 8. Section 15 of the principal Act is amended by inserting after the word "made" in the fourth line thereof the words "or confirmed".

Amendment of principal Act, s. 16—Service of copy.

9. Section 16 of the principal Act is amended by inserting after the word "made" in the fifth line thereof the words "or confirmed".

Amendment of principal Act, s. 19— Collector to forward orders.

- 10. Section 19 of the principal Act is amended—
 - (a) by inserting after the word "State" in the fourth line thereof the words "or an order has been confirmed in this State";
 - (b) by

Inter-State Destitute Persons Relief (Amendment) Act.—1931.

- (b) by inserting after the word "made" in the fourth line thereof the words "or against whom a maintenance order made elsewhere is confirmed in this State";
- (c) by inserting after the word "made" in the seventh line thereof the words "or the person on whom by law the duty to enforce a maintenance order which has been confirmed in this State is cast"; and
- (d) by inserting after the word "made" in the fourth line of paragraph 1. thereof the words "or confirmed in this State".
- 11. Section 20 of the principal Act is amended by inserting after Amendment of the word "made" in the second line of subsection (2) thereof the principal Act, s. 20words "or confirmed".

12. The principal Act is amended by inserting therein after Amendment of section 27 the following section:—
